This letter is the final response to your June 10, 2022, Freedom of Information Act (FOIA) request. Specifically, you requested the following records: "The Department's "strategic plan," that was required by Section 3(b) of Executive Order 14019 (March 7, 2021) on "Promoting Access to Voting," to be submitted to the Assistant to the President for Domestic Policy by September 23, 2021. (Date Range for Record Search: From 03/07/2021 To 06/10/2022)."

The Office of the White House Liaison conducted a search and reports there are no records responsive to your request.

While we believe an adequate search of the appropriate files was conducted for the records requested, you have the right to appeal this finding that no responsive records exist within Office of the White House Liaison. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision.
