Freedom of Information Act Request

Dear FOIA Officer:

America First Legal Foundation is a national, nonprofit organization working to promote the rule of law in the United States, prevent executive overreach, and ensure due process and equal protection for all Americans, all to promote public knowledge and understanding of the law and individual rights guaranteed under the Constitution and laws of the United States. To that end, we file Freedom of Information Act (FOIA) requests on issues of pressing public concern, then disseminate the information we obtain, making documents broadly available to the public, scholars, and the media. Using our editorial skills to turn raw materials into distinct work, we distribute that work to a national audience through traditional and social media platforms. AFL's email list contains 43,000 unique addresses, our Facebook page has 104,000 followers, our Twitter page has 48,500 followers, the Twitter page of our Founder and President has 366,300 followers, and we have another 31,500 followers on GETTR.

I. Requested Records

AFL requests the following records under the Freedom of Information Act (FOIA), 5 U.S.C. § 552(a).

- 1. All emails to/from any address that ends in @lcps.org or @loudoun.gov;
- 2. Emails with terms: "Loudoun County Public Schools" or "LCPS" "or "Loudoun":
- 3. All communications mentioning Loudoun County School Board meetings;
- 4. All communications mentioning any "harassment, intimidation, or threats" directed to Loudoun County School Board members or administrators;
- 5. All communications mentioning the names "Scott Smith" or "Jessica Smith";
- 6. All communications mentioning the terms "Loudoun county" or "LCPS" AND "sexual assault";

7. All communications mentioning the terms "Loudoun" or "LCPS" and "special grand jury" or "grand jury".

All requests should be read to exclude news articles and "news-blast" type communications received by DOJ custodians.
