Mr. Biden serves as a Director on a number of not-for-profit Boards including the WFP USA and Zero — The Project to End Prostate Cancer. From 2006- 2009 Mr. Biden served on the Board of Directors of Amtrak, serving as Vice Chairman from 2007-09. Previously, he was a founding member of the law firm, Oldaker, Biden and Belair, LLP, served in the U.S. Government having been appointed by President Clinton to serve at the United States Department of Commerce as Executive Director of E-Commerce Policy Coordination and was Senior Vice President at MBNA America Bank, N.A. Mr. Biden was also honored to serve as an Honorary Co-Chair of the 2009 Presidential Inaugural Committee and to have served in the Jesuit Volunteer Corps. Mr. Biden received a bachelor's degree from Georgetown University and a J.D. from Yale Law School and is married to Kathleen Biden and has three daughters, Naomi, Finnegan and Maisy.

### Mr. David Bohnett, Chair, The David Bohnett Foundation

David Bohnett is a philanthropist and technology entrepreneur committed to effecting positive change through community building and social activism. In addition to serving as Chair of the David Bohnett Foundation, he is Chairman of the Board of the Los Angeles Philharmonic Association and Trustee of amfAR (The Foundation for AIDS Research) and the Los Angeles County Museum of Art (LACMA). Since 1999, the David Bohnett Foundation has provided funding, state-of-the-art technology and technical support to hundreds of innovative organizations and institutions in several primary funding areas: The Fund for Los Angeles, supporting a broad spectrum of arts, educational and civic programs including the Los Angeles Philharmonic, LACMA and the Venice Family Clinic; LGBT-related causes; graduate school leadership programs at the University of Michigan, UCLA, NYU and Harvard; voting rights and registration initiatives; supporting research and public policies to reduce the toll of firearm violence; and animal research and rights. David Bohnett's many awards and distinctions include Los Angeles Business Journal's Technology Leader of the Year, Time Digital's Top 50 Cyber Elite, and Entrepreneur of the Year for Southern California. Mr. Bohnett maintains residences in Los Angeles and New York City.

## Ms. Deborah Borda, President and CEO, Los Angeles Philharmonic Association

As President and Chief Executive Officer of the Los Angeles Philharmonic Association, Borda heads one of the largest music organizations in the United States. She is responsible for the artistic, administrative, and technical operations of the Philharmonic at Walt Disney Concert Hall and the Hollywood Bowl, as well as the presentation of close to 300 concerts annually at these iconic venues. Borda has created groundbreaking educational programs and school partnerships, forging strong bonds with the greater Los Angeles community by making music more accessible to new generations of concertgoers. Born in New York City, Borda began violin studies at the age of 6, and added the viola at 15. After completing her freshman year at the New England Conservatory of Music, she transferred to Bennington College in Vermont. Following graduate studies at the Royal College of Music in London, she enjoyed an active performing career. Deborah Borda is in demand internationally as a consultant and lecturer in both music and management, and is frequently called upon to judge music competitions. She has chaired the Music Panel of both the National Endowment for the Arts and the Major American Orchestra Managers Group. Borda has also been featured in numerous national publications and television news programs.

## Mr. Gerrett Copeland, Proprietor and Chairman, Bouchaine Vineyards

Longtime friends of Vice President and Dr. Biden, Gerret and his wife Tatiana, along with a group of partners, purchased and began renovating the oldest winery in the Carneros region in 1981. They gave a nod to his family's old world heritage by naming it Château Bouchaine. A decade later, Gerret and Tatiana bought out the original partners to become sole proprietors of the winery. Prior to his involvement with Bouchaine winery, Gerret developed a successful New York Stock

Exchange brokerage firm which he sold to Dean Witter. He resides in Wilmington, Delaware, where he is very involved with environmental causes. He helped establish The Brandywine Conservancy and its Environmental Management Center in Pennsylvania, which protects the Brandywine River Valley from pollution and over-development. For 10 years, as director of the Environmental Management Center, he assisted in preserving thousands of acres of open land in Pennsylvania and Delaware. He is also active with Longwood Gardens, The Mount Cuba Center and the Napa County Land Trust. Gerret currently serves as Chairman of the Delaware Art Museum, where construction of the "Gerret and Tatiana Copeland Wing" was completed in 2007. Gerret's father, Lammot du Pont Copeland, was the 11th president of the DuPont Company. He was also a founder of the Wilmington, Delaware, chapter of the Confrérie des Chevaliers du Tastevin. His mother, Pamela Copeland, a noted horticulturalist, enjoyed fine wine as well and was the first woman in the U.S. invited to join the Chevaliers du Tastevin.

#### Mrs. Tatiana Copeland, Owner and President, Tebec Associates Limited

Tatiana Copeland is the owner and president of Tebec Associates Limited, a firm which specializes in financial and tax planning. Additionally, she is the owner and president of The Wine & Spirit Company, co-owner and president of Bouchaine Vineyards, Inc., and co-owner and vice president of Rokeby Realty Company. She has limited partnerships in various national and international ventures, including real estate, oil, and gas. She was previously employed as a manager in the International Department of E. I. DuPont de Nemours & Co. in Wilmington, and she also worked in DuPont's European headquarters in Geneva, Switzerland. Mrs. Copeland and her husband were honored in 2005 as the largest individual donors to the Delaware Art Museum's capital campaign. The great-niece of renowned Russian composer Sergei Rachmaninoff, Mrs. Copeland is well known for her support of the musical arts in Delaware. She served on the Executive Committee of the Delaware Symphony, including a tenure as the chairman and president, and on the Executive Committee of the Grand Opera House. She also contributed to the success of opera productions presented by OperaDelaware. A large variety of philanthropic causes have benefited from Mrs. Copeland's generosity, including the Delaware Humane Association, Canine Partners for Life, and the Tolstoy Foundation, an international humanitarian organization based in New York. She also contributed to the establishment of the House of Joseph II, the Ministry of Caring's AIDS hospice. Mrs. Copeland helped to sponsor some of the Russian National Orchestra's performances in the United States and Europe. She traveled with the Russian National Orchestra in Russia, England, and Italy. she received a special invitation from the Russian Government to attend the Tchaikovsky Competition, held every four years in Moscow. Born in Dresden, Germany, Mrs. Copeland was brought up in Denmark, Argentina, and the United States. She earned a B.S. in Accounting from the University of California at Los Angeles, graduating summa cum laude and Phi Beta Kappa, and an M.B.A. from the University of California at Berkeley. She speaks several languages fluently, including Russian, French, German, Italian, and Spanish. Mrs. Copeland was knighted in 1991 by The Grand Duke Vladimir of Russia with The Order of St. Michael the Archangel.

## Dr. Amy Gutmann, President, University of Pennsylvania

Dr. Amy Gutmann is the President of University of Pennsylvania and the Christopher H. Browne Distinguished Professor of Political Science in the School of Arts and Sciences at Penn with secondary faculty appointments in Philosophy, the Annenberg School for Communication, and the Graduate School of Education. She has published widely on the value of education and deliberation in democracy, on the importance of access to higher education and health care, on "the good, the bad and the ugly" of identity politics, and on the essential role of ethics-especially professional and political ethics-in public affairs. Appointed in 2009 by President Barack Obama, Gutmann chairs the Presidential Commission for the Study of Bioethical Issues. She also serves on the National Commission on the Humanities and Social Sciences, and on the Boards of the National Constitution Center, the Carnegie Corporation, and the Vanguard Group. Gutmann has won the Harvard University Centennial Medal (2003), the Carnegie Corporation Academic Leadership Award (2009), and was named by Newsweek one of the "150 Women Who Shake the World" (2011). She is an elected member of the American Philosophical Society, the American Academy of Arts and Sciences, the National Academy of Education, and is W.E.B. DuBois Fellow of the American Academy of Political and Social Science. She served as President of the American Society for Political and Legal Philosophy. Gutmann is a founding member of the Global Colloquium of the University Presidents, which advises the Secretary General of the U.N. on a range of issues, including the social responsibility of universities. Prior to her appointment as Penn's President, Gutmann served as Provost at Princeton University, where she also was the Laurance S. Rockefeller University Professor of Politics. Gutmann graduated magna cum laude from Harvard-Radcliffe College. She earned her master's degree in Political Science from the London School of Economics and her doctorate in Political Science from Harvard University. She is married to Michael W. Doyle, the Harold Brown Professor of Law and International Affairs at Columbia University. Their daughter, Abigail Gutmann Doyle, is an Assistant Professor of Chemistry at Princeton University. Their son-in-law, Jakub Jurek, is an Assistant Professor of Economics at Princeton University.

Dr. Michael W. Doyle, Harold Brown Professor of International Affairs, Law and Political Science at Columbia University

Born in Honolulu, Hawaii, he was educated in France and Switzerland and received his high school diploma from Jesuit High School, Tampa, Florida. He studied at the U.S. Air Force Academy for two years (and also qualified as a parachutist at Fort Benning) before transferring to Harvard University, where he earned his A.B., M.A. and Ph.D. (in Political Science in 1977). As an undergraduate he won the Detur Prize and was named John Harvard Scholar. As a graduate student, he held the Atherton Prize Fellowship and a Resident Tutorship in Government in Leverett House. He completed his military service in the Massachusetts Air National Guard. Professor Doyle previously has taught at the University of Warwick (United Kingdom), Johns Hopkins University, Princeton University and Yale Law School. He directed the Center of International Studies at Princeton University and chaired the Editorial Board and the Committee of Editors of World Politics. He was the vice-president and senior fellow of the International Peace Academy and is now a member of its board of directors. He has also served as a member of the External Research Advisory Committee of the UNHCR and the Advisory Committee of the Lessons-Learned Unit of the Department of Peace-Keeping Operations (UN). He is a member of the Council on Foreign Relations, New York. In 2001, he was elected a fellow of the American Academy of Arts and Sciences and in 2009 was elected a member of the American Philosophical Society. In 2009, he received the Charles E. Merriam Award of the American Political Science Association. In 2001-2003, he served as Assistant Secretary-General and Special Adviser to United Nations Secretary-General Kofi Annan. Michael Doyle is married to Amy Gutmann. They have a daughter and son-in-law and live in Philadelphia and New York.

The Hon. Ted Kaufman, Former U.S. Senator, State of Delaware, longtime friend and advisor to the Vice President

Sen. Ted Kaufman represented Delaware in the United States Senate from Jan. 16, 2009 to Nov. 15, 2010, after which he became chair of the Congressional Oversight Panel. Kaufman has taught at Duke Law School since 1991; he also has taught in the Fuqua School of Business, and the Sanford School of Public Policy. From 1995 to 1999, Kaufman served as co-chair of the Law School's Center for the Study of Congress and he regularly teaches in the Duke in D.C. program. In 1995, Kaufman was appointed by President Clinton and confirmed by the U.S. Senate as a charter member of the Broadcasting Board of Governors. This federal agency is the independent, autonomous, entity responsible for all U.S. government and government sponsored non-military international broadcasting — including Voice of America, Radio Free Europe/Radio Liberty, Radio Free Asia, Radio and TV Marti, and The Middle East Broadcasting Network. He was with Sen. Joseph R. Biden's staff from 1973 through 1994, and spent nineteen years as chief of staff. He held a senior position in all of Biden's federal campaigns. Kaufman was president of Public Strategies, a political and management consulting firm based in Wilmington, Delaware, from 1995 — 2008. He previously worked for the Dupont Company in a variety of finance, technical, and marketing positions. He has a BSME from Duke University and an MBA from the Wharton School of the University of Pennsylvania.

Mrs. Lynne Kaufman, Spouse of The Hon. Ted Kaufman

Mrs. Lynne Kaufman has been married to Former Sen. Ted Kaufman since 1960 and they reside in Wilmington, Delaware. They have three daughters, Kelly, Murry and Meg and 7 grandchildren.


