Regarding Tammy's dad, Robert W. Thomas. DOB: 08-17-23. He went to Colorado School of Minds, Rensselaer U and finally U of Michigan as I believe the war may have "disrupted" his education. At some point he "joined/qualified for Mensa.

He worked as an electrical engineer for his entire career at Consumers Power in Grand Rapids. Commuting 45 miles each day from their home in Grand Haven, MI. He had 6 children, all of whom graduated college, one from Marquette, two from Michigan and three from Western Michigan.

He served in the US Navy...

Vh5 Air Sea Rescue

Vp 21 patrol

1944/1945. He flew a Pbm plane which was a rescue plane designed for water landing and take off. We know of at least two rescues he flew in the pacific as he received accommodations for the rescues.

I think his time in the Navy and in particular flying for the Navy was one of the more significant aspects of his life as he has spent many trips traveling to Navy bases since Tammy's mom passed. He is still today a licensed pilot having owned a twin engine plane for many many years.

I'm hoping that rather than waiting for the honor guard afforded him at his funeral, he can read a letter from the VPOTUS or letterhead that recognizes his exemplary life and service to our country.

Regarding Tammy's dad, Robert W. Thomas. DOB: 08-17-23. He went to Colorado School of Minds, Rensselaer U and finally U of Michigan as I believe the war may have "disrupted" his education. At some point he "joined/qualified for Mensa.

He worked as an electrical engineer for his entire career at Consumers Power in Grand Rapids. Commuting 45 miles each day from their home in Grand Haven, MI. He had 6 children, all of whom graduated college, one from Marquette, two from Michigan and three from Western Michigan.

He served in the US Navy...

Vh5 Air Sea Rescue

Vp 21 patrol

1944/1945. He flew a Pbm plane which was a rescue plane designed for water landing and take off. We know of at least two rescues he flew in the pacific as he received accommodations for the rescues.

I think his time in the Navy and in particular flying for the Navy was one of the more significant aspects of his life as he has spent many trips traveling to Navy bases since Tammy's mom passed. He is still today a licensed pilot having owned a twin engine plane for many many years.

I'm hoping that rather than waiting for the honor guard afforded him at his funeral, he can read a letter from the VPOTUS or letterhead that recognizes his exemplary life and service to our country.

Thanks again for taking the time to meet yesterday to talk about your participation in **Live Below the Line** and bringing awareness to global hunger through undertaking the challenge. We know your participation will make an incredible difference.

As you know, participants will be committing to Live Below the Line by eating and drinking on less than the global poverty line— just \$1.50 per day—later this month, from April 29 to May 3, 2013. With 870 million people suffering from chronic hunger around the world and over 75 million people estimated to be in need of emergency food assistance this year alone, our goal is to use this campaign as a moment to bring real attention to the effort to solve global hunger. We've already been overwhelmed with how people are coming together to take the challenge— students, parents, communities of faith and people from across the country and both sides of the aisle.

As per our conversation, writing to also follow-up on potential of inviting Dr. Biden to participate in awareness activities around Live Below the Line.
