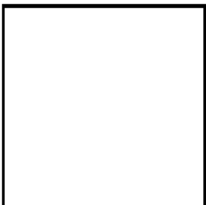

- Two Trump advisers said the Archives recently visited former president Trump's home in Florida at the end of last year to retrieve boxes of documents and items that were not properly turned over to the

agency. Does the Archives have any comment on how these missing items were identified and tracked down?

- The advisers referred to "several" boxes -- how many boxes were retrieved?
- Are there any documents that were recovered that are relevant to the House select committee's investigation into January 6?
- How did the Archives discover that the materials were missing?
- Are there additional missing documents that were not retrieved from the former president?
- The Trump advisers say that the boxes contained letters from world leaders, mementos, gifts and other correspondences -- and nothing nefarious. Does the Archives agree with that assessment? How would the archives characterize the contents of the boxes tracked down in Mar-a-Lago?
- Does it appear that the former president was improperly hiding material or engaged in unlawful behavior in keeping the documents?
- Has the archives ever had to track down materials from another president like it did with President Trump? If so, who, and what
- We understand that some ripped documents were discovered during the Trump era in classified burn bags and that White House records staff had to remove them and often tape fragments together. Can you please comment on this?

The department "told the National Archives to have its inspector general examine the matter, the person said." It is unclear what "the inspector general has done since then, in particular, whether the inspector general has referred the matter to the Justice Department."
