Freedom of Information Act Request: TSA Vetting of Illegal Aliens

Dear Mr. Clutter and Ms. Miller:

America First Legal Foundation is a national, nonprofit organization working to promote the rule of law in the United States, prevent executive overreach, and ensure due process and equal protection for all Americans, all to promote public knowledge and understanding of the law and individual rights guaranteed under the Constitution and laws of the United States. To that end, we file Freedom of Information Act (FOIA) requests on issues of pressing concern, then disseminate the information we obtain, making documents broadly available to the public, scholars, and the media. Using our editorial skills to turn raw materials into distinct work, we distribute that work to a national audience through traditional and social media platforms. AFL has over 189,000 followers on X, and our Founder and President has over 562,000 followers on X.

I. Background

Over the holiday travel season, the flying public witnessed multitudes of illegal aliens traveling through airports and boarding flights across the country. Reportedly, these

611 Pennsylvania Ave SE #231 Washington, DC 20003 320 South Madison Avenue Monroe, Georgia 30655 groups of individuals each carried plastic bags containing their belongings and a phone and were accompanied by an interpreter—all presumably paid for by non-governmental organizations (NGOs).² It is unclear whether their numbers consist of, or are in addition to, the tens of thousands of illegal aliens that the Biden Administration has proposed to house at public airports.³

The Transportation Security Administration (TSA) recognizes that "[a]viation is a preferred target for terrorists seeking to conduct spectacular mass-casualty attacks that cause economic damage and garner widespread media attention." But while the TSA rigorously screens law-abiding Americans, teffectively takes illegal aliens at their word for their identities. In October 2023, U.S. Customs and Border Protection (CBP) released statistics showing that they detained more people on the Federal Bureau of Investigation (FBI) terror watch list in fiscal year 2023 than the last six fiscal years combined. In November 2023, FBI Director Christopher Wray testified at a congressional hearing that 56 FBI joint terrorism task forces are occupied with threats coming across the border, and Department of Homeland Security (DHS) Secretary Alejandro Mayorkas could not confirm that CBP detains every suspected terrorist that crosses the Southwest border.

To uncover the extent of this national security risk and the potential that NGOs facilitating the interstate travel of illegal aliens may have influenced the DHS and TSA officials responsible for aviation screening policy, AFL requests the following records under 5 U.S.C. § 552(a):

IV. Fee Waiver

Per 5 U.S.C. § 552(a)(4)(A)(iii) and 6 CFR § 5.11(k), AFL requests a waiver of all search and duplication fees. AFL has a demonstrated ability and intention to effectively convey the information broadly to the public, and it has been granted fee waivers by the Departments of State, Defense, Education, Energy, Health and Human Services, Justice, Interior, and Homeland Security based on its status as a representative of the news media. V. Expedited Processing

AFL requests expedited processing of this request. In support of thereof, AFL certifies its compelling need for expedited processing.

AFL is "primarily engaged in disseminating information" under 6 CFR 5.5(e)(1)(ii). As explained below, this request is "urgent" because it seeks information regarding the national security risk posed by poorly vetted passengers to everyday travelers at airports across the country. This issue is of "widespread and exceptional media interest in which there exist possible questions about the government's integrity which affect public confidence," 6 CFR 5.5(e)(1)(iv). Accordingly, AFL is seeking information about the security risks considered by policymakers at DHS and TSA as decisions are made to facilitate the travel of illegal aliens around the country by air. At the very least, DHS and TSA's policies pose a grave national security risk to lawabiding American citizens flying on the same flights. 6 CFR 5.5(e)(1)(i).

Prompt disclosure of this information will inform the public about the operation of the government and enforcement of aviation security laws, and provide Congress, the media, and voters with critical insight into DHS and TSA's facilitation of the resettlement of illegal aliens across the country.
