Sara,

On June 1st, 2011 Hill International received a contract from TRAC, a Korean development company to provide project managements services for a 100,000 unit housing project in Basra, Iraq and HillStone received a contract to provide the Cold-Formed Steel framing kits on the same day. TRAC Development had previously obtained a memorandum of understanding with the National Investment Commission of Iraq to build 100,000 units in Basra, Iraq.

Hill was recommended to TRAC development by the Commerce Department because of its extensive work in the reconstruction of Iraq since end of the war. Hill had recently overseen over 12 Billion dollars of infrastructure work in Iraq.

Hill's contract for Program and Project Management and HillStone's contract for the framing system are both with TRAC Development, not with the National Investment Commission of Iraq.

Both of these contracts were subject to TRAC obtaining financing for the project and TRAC obtaining various approvals from the Ministry of Housing of the Government of Iraq.

Jim Biden was not involved in the direct negotiations between TRAC Development and Hill.

Jim did not attend any meetings in Iraq with the Iraqi government.

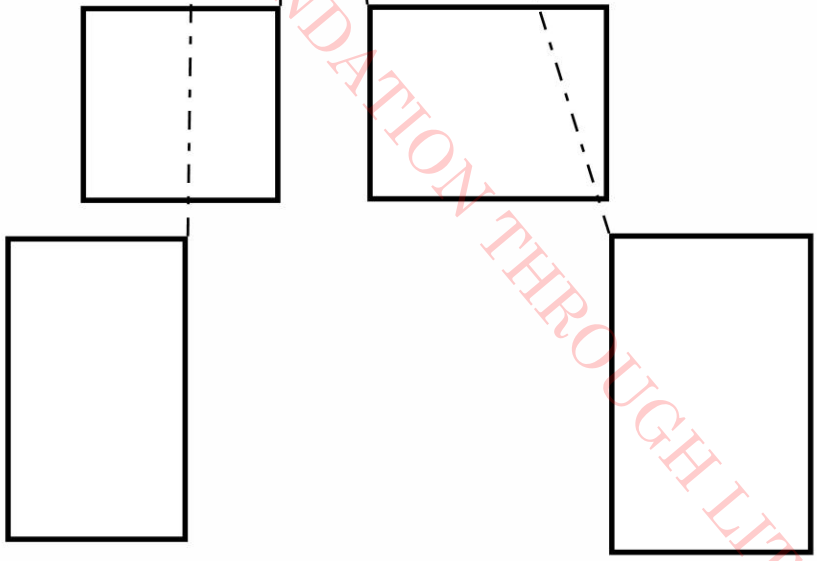

Hi Kathy/Alan,

On June 1st, 2011 Hill International received a contract from TRAC, a Korean development company to provide project managements services for a 100,000 unit housing project in Basra, Iraq and HillStone received a contract to provide the Cold-Formed Steel framing kits on the same day. TRAC Development had previously obtained a memorandum of understanding with the National Investment Commission of Iraq to build 100,000 units in Basra, Iraq.

Hill was recommended to TRAC development by the Commerce Department because of its extensive work in the reconstruction of Iraq since end of the war. Hill had recently overseen over 12 Billion dollars of infrastructure work in Iraq.

Hill's contract for Program and Project Management and HillStone's contract for the framing system are both with TRAC Development, not with the National Investment Commission of Iraq.

Both of these contracts were subject to TRAC obtaining financing for the project and TRAC obtaining various approvals from the Ministry of Housing of the Government of Iraq.

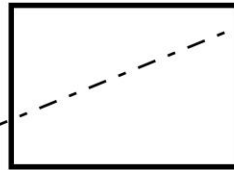

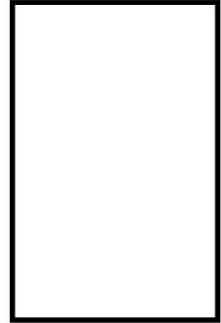
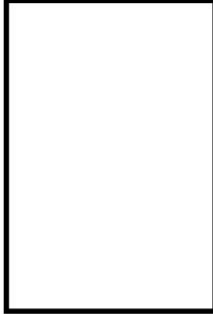

THE VICE PRESIDENT: It's an honor to be here. Madam President, I hope you'll remember me when I bring my great grandchildren by to see you in the White House and they say, Joe Biden is out there, promise me you will not say, Joe who? (Laughter.) It's the request I have of you.

Mr. President, this is a great honor to be invited to this lecture series. And it's a great honor for me. I want you to know the only reason -- I saw some eyebrows raised when it was mentioned that I ran for the United States Senate and Vice President at the same time in Delaware -- that was not -- I was not exercising Lyndon Johnson's caution. On June 1st, 2011 Hill International received a contract from TRAC, a Korean development company to provide project managements services for a 100,000 unit housing project in Basra, Iraq and HillStone received a contract to provide the Cold-Formed Steel framing kits on the same day. TRAC Development had previously obtained a memorandum of understanding with the National Investment Commission of Iraq to build 100,000 units in Basra, Iraq.

Hill was recommended to TRAC development by the Commerce Department because of its extensive work in the reconstruction of Iraq since end of the war. Hill had recently overseen over 12 Billion dollars of infrastructure work in Iraq.

Hill's contract for Program and Project Management and HillStone's contract for the framing system are both with TRAC Development, not with the National Investment Commission of Iraq.

Both of these contracts were subject to TRAC obtaining financing for the project and TRAC obtaining various approvals from the Ministry of Housing of the Government of Iraq.

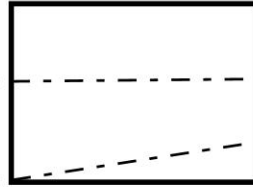

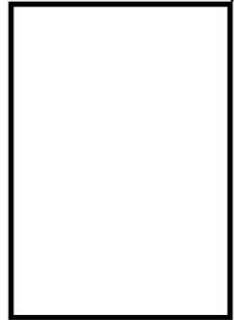
