PROHIBITED ITEMS

Before entering the U.S. Capitol Visitor Center, all visitors are screened by a magnetometer, and all items that are permitted inside the building are screened by an x-ray device. Visitors should keep their belongings with them at all times as unattended items may result in a disruption of service at the Capitol.

While certain exceptions for medical needs can be made, the following items are strictly prohibited:

- **Liquid, including water**
- **Food or beverage of any kind, including fruit and unopened packaged food**
- Aerosol containers
- Non-aerosol spray (Prescriptions for medical needs are permitted.)
- Any pointed object, e.g. knitting needles and letter openers (Pens and pencils are permitted.)
- Any bag larger than 18" wide x 14" high x 8.5" deep
- Electric stun guns, martial arts weapons or devices
- Guns, replica guns, ammunition, and fireworks
- Knives of any size
- Mace and pepper spray
- Razors and box cutters

Visitors: The Capitol Visitor Center is open from 8:30 a.m. to 4:30 p.m., Monday through Saturday. It is closed on Thanksgiving Day, Christmas Day, New Year's Day and Presidential Inauguration Days.

Official Business: Visitors with official business appointments may enter the Capitol Visitor Center as early as 7:15 a.m.

PLEASE PRINT THIS PAGE and bring it with you when you visit the U.S. Capitol to get your tour passes. (This is not your tour pass.)

TIPS FOR VISITING THE U.S. CAPITOL

- As parking is limited on Capitol Hill, visitors are encouraged to use public transportation to reach the U.S. Capitol. Train (Metrorail) stations and bus stops are nearby – the Union Station and Capitol South Metrorail stops are the most convenient to the Capitol.
- Visitors enter the U.S. Capitol through the Capitol Visitor Center. The entrance is located on the east side of the Capitol.
- You must pick up your tour pass prior to the tour time printed on your confirmation letter. From March through August, please arrive at least 45 minutes early to complete the required security and screening process. Please arrive 30 minutes early from September through February.
- To visit the Galleries of the Senate or House of Representatives, obtain separate passes from the office of your Senators or Representative. International visitors may inquire about passes at the Senate or House of Representatives Appointment Desks located inside the Capitol Visitor Center.
- The tour of the historic Capitol includes a 45-minute guided walking tour as well as a 13-minute orientation film. Escalators and elevators are located near the public stairways, and wheelchairs are available upon request at the Visitor Center.
- Please take advantage of Exhibition Hall, the Restaurant, the Gift Shops and the other amenities at the Capitol Visitor Center before or after your tour.
- The U.S. Capitol is subject to the unscheduled suspension of tours.

WHITE HOUSE ANNOUNCES 2014 SPRING GARDEN EVENT

April 26 and 27

WASHINGTON -As part of the President and First Lady's ongoing effort to open the People's House to as many people as possible, the White House will open its gardens and grounds to visitors on Saturday, April 26 from 10:00 AM to 4:30 PM EDT, and Sunday, April 27 from 10:00 AM to 2:30 PM EDT. During this event, visitors can see the Jacqueline Kennedy Garden, Rose Garden and South Lawn of the White House. Additionally, the White House Kitchen Garden - the first vegetable garden at the White

House since Eleanor Roosevelt's Victory Garden - will be accessible to guests.

This event is free and open to the public; however, a ticket is required for all attendees (including small children). The National Park Service will distribute free, timed tickets at the Ellipse Visitor Pavilion located at 15th and E Streets NW on Saturday and Sunday beginning at 9:00 AM. Tickets will be distributed -- one ticket per person -- on a first-come, first-served basis.

Please note the following items are not allowed on the White House grounds:

- * Aerosols of any kind
- * Animals (except guide dogs)
- * Backpacks (oversized)
- * Balloons
- * Food or beverages of any kind
- * Duffle bags/suitcases
- * Any pointed object
- * Fireworks/firecrackers
- * Insulated metal containers/water bottles/thermos
- * Guns/stun guns/ammunition
- * Knives of any kind
- * Mace
- * Tobacco

The U.S. Secret Service reserves the right to prohibit any other personal items. However, strollers, wheelchairs, umbrellas, and cameras are permitted.

All items needed for medical purposes will be permitted on the tour (e.g. wheelchairs, electric scooters, glucose tablets, EpiPens, etc.). Please identify and explain all items needed for medical purposes to U.S. Secret Service upon arrival.

In the event of inclement weather, the event may be cancelled. Please call the 24-hour information line at (202) 456-7041 to check on the status of the event.

This is the survey the President acknowledged in his State of the Union address this year as validating the US recovery inasmuch as the US resumed the number 1 ranking among investment destinations in the world after having lost that coveted spot to China a decade ago.
