### Dear Michael Ding:

This letter is in response to your Freedom of Information Act (FOIA) request dated August 9, 2022 for access to Biden Vice Presidential records pertaining to Vice President Biden's Communications with Hunter Biden and James Biden. Your request was received by the Archival Operations Division on August 9, 2022. FOIA requests for Biden Vice Presidential records are processed and reviewed for access under provisions of the 1978 Presidential Records Act, as amended (PRA) (44 U.S.C. §§ 2201-2209), which incorporates the Freedom of Information Act (5 U.S.C. § 552) in substantial part.

We have completed processing approximately 119 Biden Vice Presidential email messages related to this request. Of this total, 111 email messages in whole and 7 email messages in part have been exempted from release in compliance with the restrictions of the PRA and applicable FOIA exemptions, which specify what material may be released to the public. All necessary steps were taken to segregate and release non-exempt information. The 111 email messages in whole and 7 email messages in part restricted from access are listed along with the exemption categories below. Some email messages may be restricted under more than one category.

P5 -1 email message P6/(b)(6) -8 email messages PRM - 110 email messages

A list of the PRA restrictions and FOIA exemptions, as well as a copy of the finding aid that describes the processed material are attached.

#### **Scope and Content**

The materials in this series are a selective, not necessarily all-inclusive, body of records responsive to the topic of FOIA case 2022-0119-F. This researcher submitted a Freedom of Information Act (FOIA) request for material related to Vice President Biden's communications with Hunter Biden and James Biden and narrowed their request to specific terms and email senders and recipients.

This series consists of email messages involving Vice Presidential staff members from September 1, 2010 to May 25, 2012 sent and received by Hunter Biden at his Rosemont Seneca email addresses. Email communications with Hunter Biden involve Vice Presidential staff members Alan Hoffman, Michele Smith, Fran Person, Nancy Orloff, and Evan Ryan and Rosemont Seneca representatives Eric Schwerin and Ann Marie Person. Topics include the White House 2010 Open House, a schedule for the week of December 12, 2011, remarks by Dr. Biden and Vice President Biden at the 2012 TAPS National Military Survivor Seminar, and staff commentary on news coverage of Vice President Biden.

#### **System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date. The following is a list of the SRLs saved and processed in response to FOIA 2022-0119-F [1]:

Biden Vice Presidential Records: Electronic Records Exchange Email - Hunter Biden, 2009-01-20 to 2012-12-31

This SRL contains 119 responsive email messages.
