Supplemental Request for OIG Action Regarding the Department's Failure to Investigate and Prosecute Pro-Hamas Criminal Conduct

Dear Inspector General Horowitz:

Eight months ago, we asked you to investigate whether the Department's failure to protect Americans' civil rights from the pro-Hamas network and its leftist and Islamic foot soldiers¹ is the result of inappropriate considerations and bias.² In the interim, the pro-Hamas network has become more brazen and aggressive, committing numerous crimes, including, *inter alia*, conspiracies against rights (18 U.S.C. § 241), obstruction and vandalism of places of worship (18 U.S.C. § 248(a)(2), (3)), destruction of government property (18 U.S.C. § 1361), money laundering (18 U.S.C. § 1956), material support for a designated foreign terrorist organization (18 U.S.C. § 2339A), and civil violations, including, *inter alia*, under 42 U.S.C. § 1985(3).³

For example:

• On or about June 24, 2024, pursuant to an unlawful conspiracy, the pro-Hamas network by force or threat of force and by physical obstruction, intentionally injured, intimidated, and interfered with American citizens lawfully exercising or seeking to exercise their First Amendment right of religious freedom at the Adas Torah synagogue in Los Angelas, California. Despite clear violations of applicable California and federal laws, published reports are that none of the pro-Hamas attackers were arrested. When police did arrive, the pro-Hamas mob dispersed into surrounding residential neighborhoods. Video shows individuals, many using keffiyeh head scarves to conceal their faces, looking for Jews to attack. According to one witness:

[B]ehind the phalanx of LAPD, on the sidewalk in front of the synagogue, were the Hamas supporters. When I walked up to the police with my boys and asked if I could enter the synagogue, they told me not to come any closer and said that I should leave. I asked calmly but incredulously, "Shouldn't you be making sure this place stays open?" The reply was: "You should leave."⁵

There are allegations that local political officials in the Office of the Mayor issued a standdown order to the Los Angeles Police Department; regardless, according to a liberal CNN commentator, this was a "pogrom," not a protest.⁶

- On or about June 10, 2024, pursuant to an unlawful conspiracy, the pro-Hamas network mobilized a masked, disguised, and violent mob to, *inter alia*, injure, oppress, threaten, or intimidate Americans in the free exercise or enjoyment of their First Amendment rights. Specifically, the pro-Hamas network intended to prevent or hinder Americans' free exercise or enjoyment of their right to attend, gather, and view a memorial to the hundreds of innocents at the Nova Music Festival in Israel who suffered unspeakable crimes, including murder, rape, and mutilation, at the hands of Hamas terrorists on October 7, 2023. Shockingly, the pro-Hamas mob celebrated the assault on this memorial, praised Hamas's October 7 violence, and called for similar crimes against Americans.
- On or about June 8, 2024, pursuant to an unlawful conspiracy, the pro-Hamas network mobilized a mob takeover of Lafayette Park in Washington, D.C., vandalizing federal property and attacking federal law enforcement in violation of the criminal laws of the United States and the District of Columbia. The confessed purpose was to provide designated foreign terrorists with material support and assistance, in facial violation of 18 U.S.C. § 2339A(b), and to intimidate or coerce American citizens and/or influence the policy of the American government by intimidation or coercion in violation of 18 U.S.C. § 2331(5). Despite considerable damage, not a single arrest was made. 11

The Department's political leaders have made "domestic terrorism" a central talking point and a singular domestic intelligence, investigative, and enforcement priority. ¹² It has characterized *all* January 6 protestors as "domestic terrorists" ¹³ and mobilized federal law enforcement against parents for protesting at school board meetings. ¹⁴ However, it has not applied the same label to the pro-Hamas network, notwithstanding the fact that this network was created and exists to provide material support to designated foreign terrorist groups ¹⁵ and is engaged in conduct that precisely meets the statutory definition of the term. ¹⁶

American parents opposed to masks, critical race theory, or secretive gender "transitions" *never* engaged in the sort of violence and intimidation practiced by the pro-Hamas network on almost a daily basis. Yet, while the Department found its voice to smear parents as potential domestic terrorists, about the pro-Hamas network,¹⁷ it has nothing to say. The only apparent justification for the fact that American parents merited a specific Attorney General's Memorandum and the organized attention of federal law enforcement, while the foreign and domestic supporters of a designated foreign terrorist organization have not, is that the pro-Hamas network and its supporters in Michigan and elsewhere are apparently a political ally and client of the current administration.¹⁸

The pattern of governmental underenforcement here echoes the 1960s, as the police and local prosecutors refused to prevent attacks by racist groups, including the Ku Klux Klan. In much the same way that local prosecutors in the Jim Crow South refused to fairly charge white racists who broke laws, attacked black Americans, and violated their civil rights, leftist prosecutors in Chicago, Los Angeles, and New York City have refused to fairly charge pro-Hamas criminals who have broken laws, attacked Jewish and other Americans, and violated civil rights. In Los Angeles, city officials have even voted to use local tax dollars to fund legal counsel for pro-Hamas criminals. On the control of the pro-Hamas criminals.

The Department once used its authority to protect civil rights. Now, by closing its eyes and standing quietly as local officials protect truly genocidal anti-Semites for political or ideological gain, it dishonors its history. The government is required not only to treat citizens equally but to protect them from private violence and intimidation; a political decision to stand down and thereby deny some American citizens protection from the pro-Hamas network's racist, anti-Christian, and anti-Semitic violence and intimidation denies equal protection and violates the Constitution.²¹

The Department's political officials have shamefully abdicated their responsibility to enforce the law and protect civil rights. Accordingly, we renew our January 2, 2024, request that you exercise your authority under 5a U.S.C. § 4 to determine whether the Department's decision to ignore the federal crimes committed by the pro-Hamas network is based on improper considerations and bias.
