The search of TdA returned incidents unrelated to this request (TdA hit on terms such as, but not limited to: outdated, HITDA, etc.). Gang Affiliation is no longer collected on the arrest report. Four juvenile arrest reports meet the search criteria.

Note<sup>3</sup>: ISR Data is limited to ISR reports containing the term(s) Tren De Aragua or TdA or Venezuela/n and Gang in the narrative for stops that occurred between January 1, 2023, and September 10, 2024. E. All records referencing the arrests of Edwin Camejo,<sup>2</sup> Adelvis Rodriguez-Carmona,<sup>3</sup> and any other known members of Tren de Aragua, including but not limited to arrest affidavits and other applicable crime or incident reports.  
F. All communications with the U.S. Immigration and Customs Enforcement, Enforcement and Removal Operations Field Office in Chicago, Cook County Police Department, and Cicero Police Department referencing gang activity in the state of Illinois.
