# Dear Michael Ding:

This letter is in response to your Freedom of Information Act (FOIA) request dated August 9, 2022 for access to Biden Vice Presidential records pertaining to Vice President Biden's Communications with Hunter Biden and James Biden. Your request was received by the Archival Operations Division on August 9, 2022. FOIA requests for Biden Vice Presidential records are processed and reviewed for access under provisions of the 1978 Presidential Records Act, as amended (PRA) (44 U.S.C. §§ 2201-2209), which incorporates the Freedom of Information Act (5 U.S.C. § 552) in substantial part.

We have completed processing approximately 294 Biden Vice Presidential email messages related to this request. Of this total, 126 email messages in whole and 99 email messages in part have been exempted from release in compliance with the restrictions of the PRA and applicable FOIA exemptions, which specify what material may be released to the public. All necessary steps were taken to segregate and release non-exempt information. The 126 email messages in whole and 99 email messages in part restricted from access are listed along with the exemption categories below. Some email messages may be restricted under more than one category.

P2/(b)(2) – 4 email messages P4/(b)(4) – 1 email message P5 – 14 email messages P6/(b)(6) –107 email messages (b)(7)(E) – 1 email message PRM – 111 email messages

A list of the PRA restrictions and FOIA exemptions, as well as a copy of the finding aid that describes the processed material are attached.

The remaining 69 email messages in whole and 99 email messages in part are available. You can then click on the zip files under "Download Zip file" for 2022-0119-F [4]. This completes processing of 2022-0119-F.

If you are unsatisfied with this response, you have the right to file an administrative appeal of the withholding decisions under the exemption categories listed at 44 U.S.C. § 2204(a). The appeal must be submitted in writing to the Director, Archival Operations Division, National Archives and Records Administration, 700 Pennsylvania Avenue, NW, Room G-7, Washington, DC 20408-0001. You should also include a copy of your original request and our denial. Both your appeal letter and the envelope should be clearly marked "PRA/FOIA Appeal." To be considered timely, your appeal must be postmarked or electronically submitted within 90 calendar days from the date of this letter

### **Scope and Content**

The materials in this series are a selective, not necessarily all-inclusive, body of records responsive to the topic of FOIA case 2022-0119-F. This researcher submitted a Freedom of Information Act (FOIA) request for material related to Vice President Biden's communications with Hunter Biden and James Biden and narrowed their request to specific terms and email senders and recipients.

This series consists of email messages from February 26, 2009 to April 1, 2014 with James Biden which include some of the narrowed terms. Email communications with James Biden involve Vice Presidential staff members Nancy Orloff, Kellen Suber and Alexander Mackler. The topics of these email messages relate to event information for a Middle Class Task Force event in Philadelphia, Pennsylvania, an invite from Paul Laudicina to attend his book launch event, forwarding of photos taken by the White House photographer of Vice President Biden with James and Jaimie Biden in his West Wing office, and a forwarded media request from Turner Sports.

This series also contains additional email messages involving Rosemont Seneca Global Advisors from the year 2016 which include narrowed terms. The topics of these email messages relate to scheduling of Vice President Biden and Dr. Biden signing their final tax forms and preparation of Vice President Biden's official public financial disclosure forms for the fiscal year 2015. In addition, topics include scheduling of West Wing tours, a secure international video call between Vice President Biden and Dr. Biden in March 2016, and a photoshoot for Vice President Biden and Hunter Biden's 2016 interview with *Popular Mechanics*.

This series also contains email messages from September 12, 2014 and January 22, 2015 with Sara Biden which include some of the narrowed terms. Email communications with Sara Biden involve Vice Presidential staff members Chris Mackler and Anthony Bernal. The topic of these email messages relate to a photograph taken at the 20th Anniversary of the Violence Against Women Act reception held at the Naval Observatory and the White House issued press statement on the passing of Senator Wendell Ford.

## **System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date. The following is a list of the SRLs saved and processed in response to FOIA 2022-0119-F:

This SRL contains 6 responsive email messages.
