Location: Vice President Biden will be speaking at the Sheriff's House, located at 211 Delaware St, New Castle, DE. Guests may enter the event through a security checkpoint located at 203 Delaware Street, outside of the *New Castle Weekly* offices. *Note: This event will be held OUTDOORS. Please dress appropriately in warm clothing.*

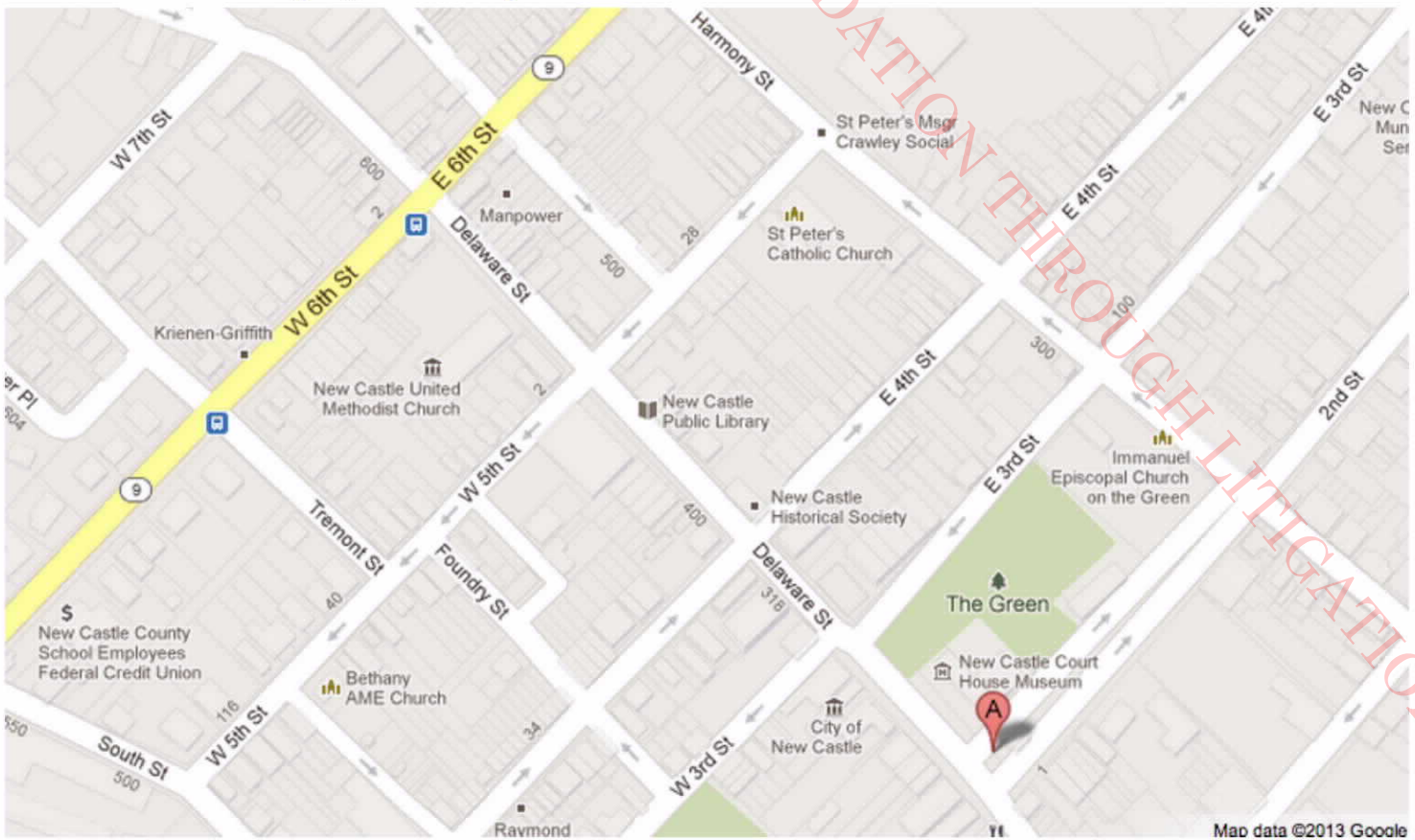
Event Time: The event begins at 230pm. Guests may enter the speech location beginning at 1pm.

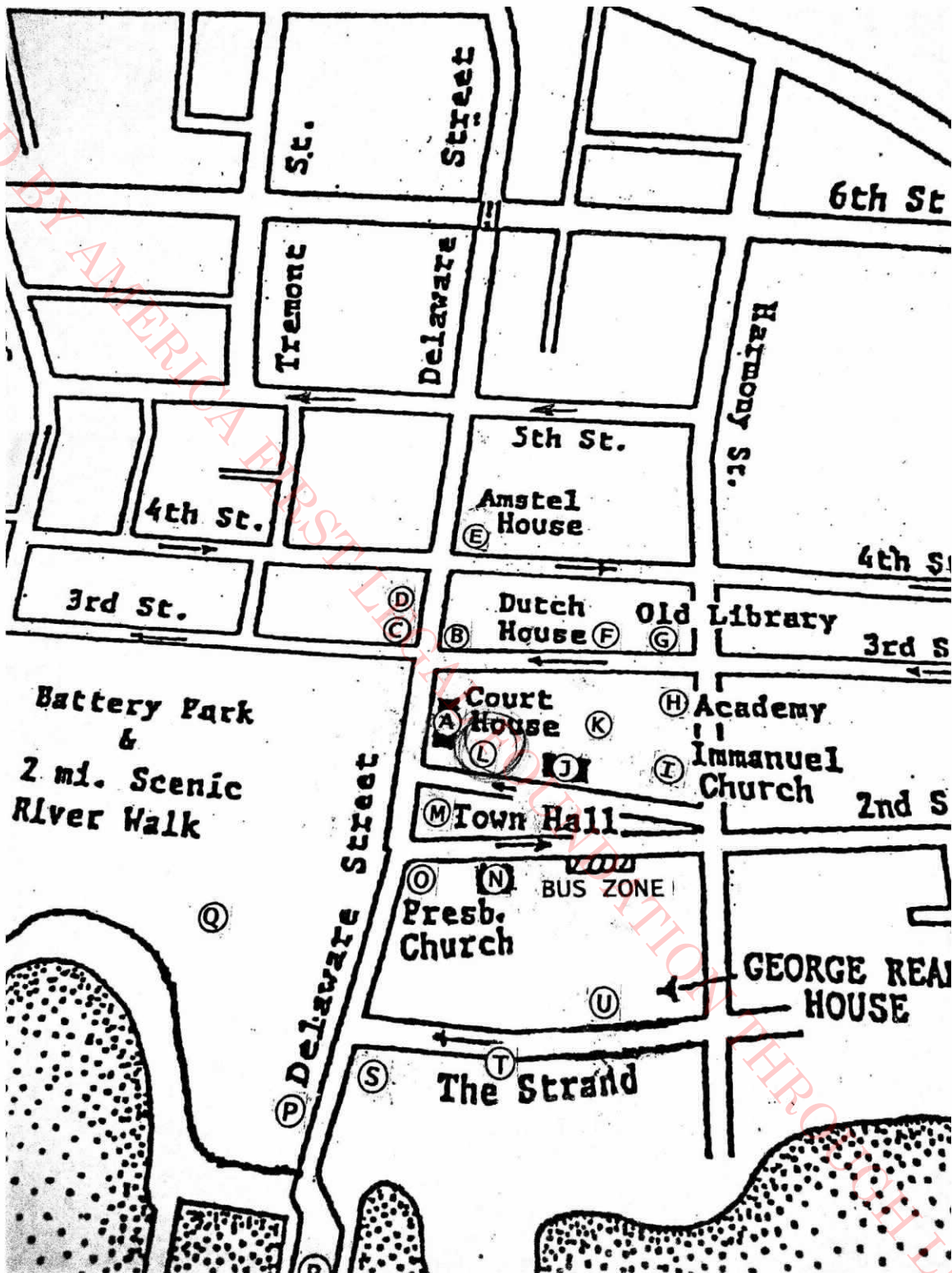
Parking: Limited street parking will be available within 4-5 blocks of the event. Please plan to arrive early as spots are limited and be prepared for a short walk to the Sheriff's House. An ADA-accessible point for drop-off ONLY is located in front of the Trader's Cove Coffee Shop across the street from the Old Courthouse at 206 Delaware Street.

NOTE: Due to heightened security, every guest will be required to go through airport-style magnetometers, and certain items will be prohibited from the event, including but not limited to, signs, oversized bags, bottles, tripods, and umbrellas.
