Michelle passed your message last week while we were in Africa, and I wasn't in a position to look up the specifics for Tanzania. She reminded me today. Sorry about that.  
Bottom line up front:

FOIA-6

Here's a quick summary:

Tanzania is a developing nation in the lowest 25% of the world's economies. It is an east African nation with a tropical climate. Weather is hot and humid, although temperatures are cooler in mountainous regions of the interior.

Medical care is substandard throughout the country. A few private facilities in Dar Es Salaam provide adequate care for common conditions. In the event of serious medical conditions every effort should be made to go to Nairobi, Kenya. Shortages of routine medications and supplies may be encountered. Adequate evacuation coverage for all travelers is a high priority.

#### **IMMUNIZATION RECOMMENDATIONS**

- **Hepatitis A**—*Recommended for:* all travelers.
- **Typhoid**—*Recommended for:* all travelers.
- **Hepatitis B**—*Recommended for:* prolonged stays; frequent short stays in this or other high risk countries; adventure travelers; the possibility of acupuncture, dental work, or tattooing; all health care workers; the possibility of a new sexual partner during stay; and travelers with high potential to seek medical care in local facilities. Consider for short stays in travelers desiring maximum pre-travel preparation. Increased awareness is recommended regarding safe sex and body fluid/blood precautions.
- **Yellow fever**—Required for travelers coming from countries with risk of yellow fever transmission. *Recommended for:* not recommended for any traveler unless it is officially required for entry. No human cases of YF have ever been reported in Tanzania, and a WHO panel has determined the evidence for lack of transmission is overwhelming. Both WHO and CDC have announced plans to change their vaccination recommendation for Tanzania with their 2011 publication cycle. Travax continues to note Tanzania's official status as "transmission risk is present" because Tanzania is listed as such by WHO for determining entry requirements under the International Health Regulations.
- **Rabies**—Risk occurs in most parts of the country except Zanzibar is likely to be rabies-free. *Recommended for:* prolonged stays with priority for young children. Also recommended for shorter stays at locations more than 24 hours travel from a reliable source of human rabies immune globulin and rabies vaccine for postexposure treatment; occupational exposure; all adventure travelers, hikers, cave explorers, and backpackers. Consider for risk-averse travelers desiring maximum pre-travel preparation. All dog bites or scratches while in this country should be taken seriously and post-exposure prophylaxis sought even in those already immunized.
- **Meningococcal meningitis**—Quadrivalent vaccine (A, C, Y, W-135) —*Recommended for:* travelers during the dry season (May through October) that anticipate prolonged contact with the local populace, risk-averse travelers during the dry season, and all health care workers throughout the year. Although Tanzania does not lie within the standard meningitis belt, a pattern of epidemic outbreaks in the past decade makes this country epidemic prone. Epidemic activity has been reported primarily in the central region of the



country and in regions surrounding Lake Victoria. (Note: Tanzania's dry season differs from countries in the meningitis belt because it lies south of the Equator.)

- **Cholera**—*Recommended for:* aid and refugee workers only. Vaccine is available in many countries, but not in the U.S.
- **Seasonal influenza**—Flu is transmitted throughout the year in the tropics and all travelers are at increased risk. *Recommended for:* all travelers. Consider a standby treatment course of oseltamivir for unvaccinated travelers, especially those who are at high risk for complications from influenza.
- **2009 H1N1 flu**—Epidemic potential still exists. *Recommended for:* all travelers. Consider a standby treatment course of oseltamivir for unvaccinated travelers, especially those who are at high risk for complications from influenza.
- **Routine vaccinations** (adults only)
  - *Tetanus/diphtheria/pertussis.* Adequate primary series plus booster within the last 10 years (Tdap or Td). Adults who have not received a previous dose of an acellular pertussis-containing vaccine in adulthood should receive a one-time dose of Tdap vaccine in place of a Td booster.
  - *Measles.* Indicated for those born in 1957 or later (1970 or later in Canada) without history of disease or of 2 adequate doses of live vaccine at any time during their life. Many countries (including the U.K.) recommend that adults need to have had only 1 countable dose at any time during their life.
  - *Pneumococcal.* All adults over 65 and those with chronic disease or compromising conditions.
  - *Polio.* Adequate primary series and 1 adult dose.
  - *Varicella.* Indicated for all persons born outside the U.S. or born in the U.S. after 1979, except not indicated for persons with an adequate vaccination history (2 lifetime doses), reliable evidence of previous infection, or laboratory confirmation of immunity.

## MALARIA

- **General information:** predominantly *P. falciparum*. Transmission occurs throughout the year, and is highest during the rainy season from November through May.

### Protective recommendations:

- *Chemoprophylaxis is recommended for all travelers:* altitudes below 1,800 meters (6,000 feet), including all cities and towns.
- *No protective measures are necessary (no evidence of transmission exists):* altitudes above 1,800m (6,000 feet).
- **Protective measures:** Evening and nighttime insect precautions are essential in areas with any level of transmission. Atovaquone/proguanil (Malarone), doxycycline, and mefloquine are protective in this country. Primaquine may be used in special circumstances (G6PD testing is required).

## TRAVELER'S DIARRHEA

- High risk throughout the country including deluxe accommodations in major cities. Food and beverage precautions are essential in order to reduce chance of illness.
- Travelers should carry loperamide and/or a quinolone antibiotic for presumptive self-treatment of diarrhea if it occurs.

## OTHER

- **HIV/AIDS** is estimated to be present in 6% of the adult population putting this country in the top tier of all countries. Travelers should clearly understand STD concepts and risks for HIV transmission.
- **Tuberculosis** is common in all developing countries. However, this country has a prevalence of over 100 cases per 100,000 population, the highest risk category. Travelers planning to stay more than 1 month should have pre-departure PPD skin test status documented. Travelers should avoid crowded public places and public transportation whenever possible. Domestic help should be screened for TB.
- **Dengue** fever occurs in urban and rural areas. Daytime insect precautions are recommended.

- **African trypanosomiasis** is endemic in focal areas throughout the country including game parks such as Tarangire, Serengeti, and the Ngorongoro Crater. Insect precautions are recommended.
- **Schistosomiasis**, transmitted by waterborne larvae that penetrate intact skin, presents significant risk throughout the country. Highest risk exists in Lake Victoria, Lake Malawi, and surrounding regions. Travelers should avoid freshwater exposure.
- **Altitude sickness**: Chemoprophylaxis with acetazolamide should be considered for travelers to altitudes above 2,400 meters (8,000 feet). Travelers with respiratory or cardiac problems, or sickle cell trait or sickle cell disease, should avoid altitudes above 3,000 meters (10,000 feet). Climbers summiting Mt. Kilimanjaro reach an elevation of 6,000 meters. Itineraries often summit on the fifth day which many trekkers do not tolerate.
- **Security** – *Warning against Travel*: Due to ongoing security concerns, an Australian consular warning currently advises against all travel to the border areas with Rwanda, Burundi, and the Democratic Republic of Congo. *Other Information*: Violent crimes including carjackings, rape, and armed banditry occur in Dar Es Salaam, on Zanzibar, and incidents have been reported from all national parks and reserves. Utilize only regular tourist routes. Political tension can be extremely high on Zanzibar and Pemba. Advise extraordinary vigilance and strict adherence to personal security strategies at all times.

# Initial Phase of Construction

Completion by September 11, 2011



The final resting place of the passengers and crew is the heart of the Flight 93 National Memorial and will remain untouched. Visitors will be able to view the crash site from the **Memorial Plaza**. The names of the 40 passengers and crew will be inscribed on the wall of the plaza as it follows the flight path of the plane.

At the **Arrival Court**, visitors will be greeted by volunteer Ambassadors and National Park Service rangers who will be available to answer questions and provide additional information about September 11 and the actions of the passengers and crew of Flight 93.

## Construction 2010-2011

- The open field will be graded to define the **Field of Honor** and create a gentle slope down to the crash site.
- The **Ring Road** (around the open field) will be built to provide access to the crash site.
- A parking area and **Arrival Court** will be constructed near the Memorial Plaza.
- The **Memorial Plaza** will be built in front of the crash site for public viewing of the area.
- The **Approach Road** to the park will extend from U.S. Route 30 and will lead visitors to the Ring Road.



# Next Phase of Construction

Large memorial walls will frame the sky where Flight 93 once flew. The height of the walls will approximate the altitude of the plane (40-50 feet) as it passed overhead. Visitors will pass through the **Entry Portal** for their first view of the crash site and the open expanse of the Field of Honor. The **Visitor Center** with interpretive exhibits will be built between the walls. Visitors may then drive or walk to the Memorial Plaza and reflect upon their experience and the story of Flight 93.

Encircling the Field of Honor will be a tree-lined walkway, or **Allée**, built on a raised earth form, at the same time as the Portal Walls and the permanent Visitor Center. The Allée will be flanked by **40 Memorial Groves** of trees.

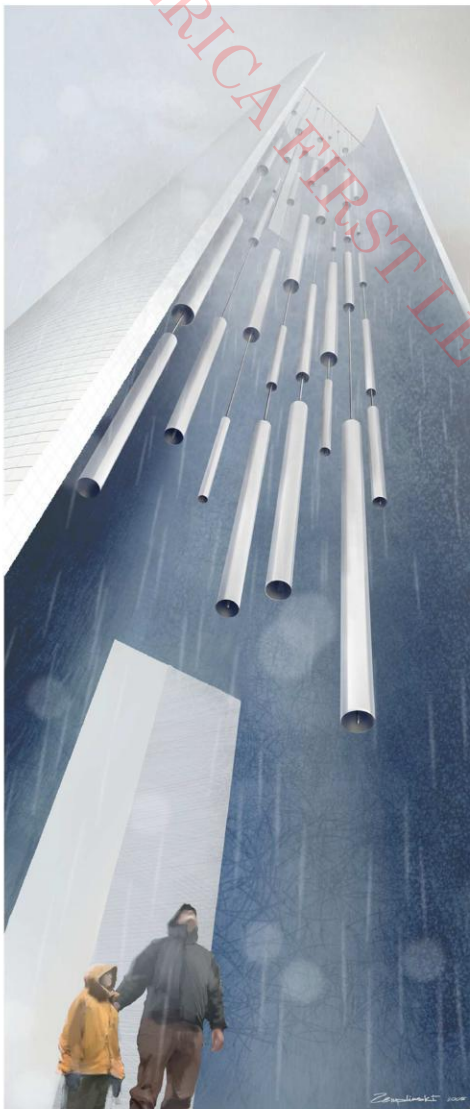

Philadelphia native **Lorraine G. Bay**, 58, loved her job as a United Airlines flight attendant. For thirty-seven years, Bay's twinkling smile and caring ways put passengers at ease. Although she was one of United's most senior flight attendants, Lorraine preferred to work in the Coach section. She mentored younger flight attendants and never failed to remember her co-workers and family with special cards and unique gifts. Two of Bay's colleagues received cards postmarked September 11, 2001, indicating that they were mailed that fateful morning. Bay and her husband of twenty-two years made their home in East Windsor, New Jersey.

**Sandy Waugh Bradshaw**

Hometown: Greensboro, NC

Occupation: Flight Attendant, United Airlines

Thirty-eight year old **Sandy Waugh Bradshaw**, a native of Climax, North Carolina, always wanted to be a Flight Attendant, the perfect career for someone who loved meeting people and traveling. After eleven years in the field, she was now flying only two trips per month, allowing her time at home with her two toddlers, her teenage stepdaughter, and her husband, a pilot for US Airways. When faced with the hijack situation on September 11, Bradshaw called United Airlines to report the emergency and describe the terrorists. Then she called her husband in their Greensboro, North Carolina home. He recalls Sandy saying that she and others on the plane were boiling water to throw on the hijackers. As the call ended, she reported that everyone was running up to first class.

**Wanda Anita Green**

Occupation: Flight Attendant, United Airlines

**Wanda Anita Green**, 49, was a Flight Attendant with United Airlines for twenty-nine years, fulfilling a dream of flying and seeing the world. According to her mother, Wanda was one of the first African Americans flight attendants with United Airlines. Wanda was a dedicated mother to her two children, a deacon in her church, and active in her local community of Linden, New Jersey. She earned her real estate license and planned to open her own real estate office after retiring from United. Wanda planned to visit her family in Oakland, California during her layover following the September 11 flight to the West Coast.

**CeeCee Ross Lyles**

Occupation: Flight Attendant, United Airlines

Just nine months before September 11, 2001, **CeeCee Ross Lyles**, 33, was working as a police officer in her hometown of Fort Pierce, Florida. After several years in law enforcement, she embarked on a new career as a Flight Attendant in January 2001, fulfilling her childhood dream. She and her husband, also a police officer, had been married for little more than a year, forming a family with four sons. During the hijacking of Flight 93, CeeCee phoned her husband, reaching their answering machine. She told him, "I hope to be able to see your face again, baby. I love you. Good-bye." In a second call five minutes before the crash, the couple spoke and prayed together. Her husband recalls that CeeCee told him, "Tell the boys I love them. We're getting ready to do it now. It's happening!"

**Deborah Jacobs Welsh**

As the purser on Flight 93, **Deborah Jacobs Welsh**, 49, was assigned to First Class and was responsible for overseeing the flight attendants. With more than twenty-five years of experience with three airlines, she was well-qualified to handle the role. The six-foot tall Welsh was raised in Philadelphia, the eldest of six children. She loved to travel and embraced the cultures of the exotic places she visited. She cared deeply about animals, and was compassionate and thoughtful, delivering leftover airline meals and warm winter clothing to homeless people in the Manhattan neighborhood where she lived with her husband.

**Christian Adams**

Reason for travel: business

A Fulbright grant recipient and a well-regarded figure in the wine industry, **Christian Adams**, 37, was en route to San Francisco on September 11 for an event promoting German wines. Holding degrees in viticulture, wine making, and marketing from universities in Germany and from the University of California at Davis, Adams was responsible for worldwide promotion of his country's wines for the German Wine Institute in Mainz, Germany. A colleague from the German Wine Information Bureau in New York recalled Adams' thoughtful, quiet manner and his depth of knowledge of the wine business. Adams, a resident of Biebelsheim, Germany, is survived by his wife and two children.



**Todd M. Beamer**

**Todd M. Beamer**, 32, an account manager for Oracle, a computer software company, left his Cranberry, New Jersey home on September 11 for a one-day business trip to San Francisco. Beamer was raised in the Chicago area and graduated from Wheaton College and earned an MBA from DePaul University. Caught up in the hijacking of Flight 93, Beamer tried to reach his wife by Airfone. When the call was not connected, Beamer dialed "0" and reached an Airfone customer service representative who says that Beamer calmly provided critical information about events on the plane and relayed messages for his pregnant wife and two children. At Beamer's request, the representative joined him in praying the Lord's Prayer. At the end of his call, she says she heard him say to others on the plane, "Are you ready? Okay. Let's roll."

**Alan Anthony Beaven**

**Alan Anthony Beaven**, 48, practiced law in his native New Zealand, then in England, New York, and most recently, California. His passions were his family, his spiritual journey, and protecting the Bay Area's water quality, tirelessly prosecuting violators of the Clean Water Act. Then he, his wife, and their young daughter planned to leave for a year's stay in India where Alan would provide legal advice regarding that country's pollution and deforestation problems. At age 20, **Deora Frances Bodley** of San Diego, California was the youngest person aboard Flight 93. She was a peer counselor to troubled teens and tutored in an afterschool program. Deora was studying French and psychology, aspiring to become a child psychologist. Remembered as independent and introspective, Deora loved her family and enjoyed reading and writing. On September 11, she was flying home after visiting friends in New Jersey. She is survived by her mother and a sister.

**Marion R. Britton**

It was **Marion R. Britton's** knack for engaging strangers in conversation that launched her 21-year career with the U.S. Census Bureau. Colleagues and family remember Britton's generosity, her frankness, and her dedication to the Bureau. On September 11, Britton, 53, of Brooklyn, New York, now the Assistant Regional Director of the New York office, was flying with co-worker Waleska Martinez to attend a conference in San Francisco. During the hijacking, Britton phoned a longtime friend and tearfully told him it felt like her plane was turning and was going to crash. Marian is survived by a brother.

The Minnesota native was a graduate of the University of Minnesota and Pepperdine University. On September 11, Burnett was returning home to San Ramon, California where his wife and three children were waiting. Tom's four phone calls to his wife from on board hijacked Flight 93 provided vital information to the passengers and crew and reveal the plans they were making to take back the plane. She recalls Tom saying, "We have to do something. We can't wait for the authorities . . . It's up to us. I think we can do it."

**William Joseph Cashman**

Cashman served as a paratrooper in the U.S. Army 101<sup>st</sup> Airborne Division, studied martial arts, and taught night school classes to apprentice ironworkers. Cashman was proud of the fact that during his forty years with Ironworkers Local 46, he helped to construct the World Trade Center. The tall, wiry native New Yorker loved spending time outdoors, and often hiked in parks near his home, as well as out West. He is survived by his wife of thirty-one years.

**Georgine Rose Corrigan**

Don grew up in South Orange, New Jersey, had an electrical engineering degree from Massachusetts Institute of Technology and earned an MBA from Rutgers University. In addition to her nursing degree from the University of Rochester, Jean held a Master's Degree in Education from Columbia University. When the Petersons married in 1984, each had three children from a previous marriage. Don's personal Bible was recovered at the Flight 93 crash site, complete with a handwritten list of men for whom he was praying.

**Mark David Rothenberg**

Age: 52

Hometown: Scotch Plains, NJ

Occupation: owner of MDR Global Resources

Reason for travel: business

**Mark David Rothenberg**, 52, of Scotch Plains, New Jersey, was an intense, successful businessman accustomed to frequent flights to Asia for his importing business, MDR Global Resources. He always flew First Class and enjoyed conversing with people on the long international flights. He had an amazing memory for numbers and a mind like a calculator. Rothenberg was raised in Brooklyn, New York and graduated in 1970 from Franklin & Marshall College. Mark, or “Mickey,” as he was known to friends and family, had previously worked in the family glassware business, becoming the top salesman and eventual owner. Though he worked long hours, Rothenberg was devoted to his wife and two children. On September 11, Rothenberg was traveling to Taiwan.

**Christine Ann Snyder**

Age: 32

Hometown: Kailua, HI

Occupation: Arborist and Project Manager, The Outdoor Circle

Reason for travel: attending a conference

Hawaii native, **Christine Ann Snyder**, 32, was a Project Manager and certified Arborist for The Outdoor Circle, Hawaii's oldest nonprofit environmental group. According to her family, the beautification of Hawaii was her profession, pride, and joy. During her six years with The Outdoor Circle, Chris supervised volunteers in planting trees and worked to protect trees and landscapes from development. She held a degree in political science from the University of Hawaii. On September 11 she was returning from the National Urban Forestry Conference in Washington, D.C. and an impromptu, first-time visit to New York City. A connecting flight in San Francisco would have taken Snyder home to Kailua, Hawaii and her husband of just three months.

**John Talignani**

Age: 74

Hometown: Staten Island, NY

Occupation: retired Bartender

Reason for travel: attending stepson's memorial service

As a bartender and steward at Manhattan's Palm restaurants for twenty years, **John Talignani**, 74, met a fair share of celebrities. But the World War II Army veteran was down-to-earth, a family man dedicated to his late wife, Selma, and her three sons whom he helped to raise. John was born in Italy, grew up in Brooklyn, New York. In his retirement, Talignani, now of Staten Island, loved following the New York Mets baseball team and making pizza for family gatherings, a holdover from his days of owning a pizzeria. The end of Talignani's life was doubly tragic: John, and his stepsons boarded separate flights to California to attend a memorial service for John's stepson and their brother who had been killed in an automobile accident while honeymooning in California.

**Honor Elizabeth Wainio**

Age: 27

Hometown: Baltimore, MD

Occupation: District Manager, Discovery Channel Stores

Reason for travel: business

Two days before September 11, **Honor Elizabeth Wainio**, 27, returned from a long-awaited trip to Europe. Now, the Catonsville, Maryland native was on her way to San Francisco for a company-wide business meeting for Discovery Channel Stores. After graduating from Towson University, "Lizz", as her friends called her, found her niche in retail, quickly rising from sales positions to management. After joining Discovery's retail division in 1999, she became a top-performing manager and was promoted to District Manager for New York and New Jersey. During the hijacking of Flight 93, Wainio phoned her stepmother who recalls her words, "They're getting ready to break into the cockpit. I have to go. I love you. Good-bye." Elizabeth is survived by parents, stepparents, a brother, and a sister.

Preamble to the Flight 93 National Memorial Mission Statement



On September 11, 2001, at 10:03 a.m., United Airlines Flight 93 passed over this building and crashed, killing all 40 passengers and crew members, as well as the four terrorists who hijacked the aircraft. The crash site is visible to the east from an overlook outside this building.

This building and the immediate area served as the Command Post during the investigation and recovery phase from September 11 until September 24, 2001. Today, it serves as a temporary visitor center until the first phase of the permanent Memorial is completed on September 11, 2011.





# America Attacked!

September 11, 2001

On the morning of September 11, 2001, 19 al Qaeda terrorists hijacked four commercial U.S. airliners, departing Boston-Logan, Washington-Dulles and Newark Airports in a strategically planned attack against the United States. These terrorists intentionally flew two jet airliners into the World Trade Center's Twin Towers in New York City and a third aircraft into the Pentagon in Arlington, Virginia. A fourth aircraft, United Airlines Flight 93, crashed into the open field beyond this building, killing all passengers, crew members, and terrorists on board.

The four aircraft strikes killed nearly 3,000 people, the deadliest attack on American soil by a foreign entity.

*9/11 Commission Report: The National Commission on Terrorist Attacks Upon the United States, 2004, 3<sup>rd</sup> monograph edition, 2006.* On November 27, 2002, the 9/11 Commission was chartered by Congress to prepare a complete account of the circumstances surrounding the attacks on September 11, 2001, including the preparedness for and the immediate response to the attacks. The Commission was also mandated to recommend measures to guard against future attacks.



Osama Bin Ladin, founder and leader of al Qaeda, an Islamist terrorist group dedicated to opposing the United States with force and violence, was responsible for threats and hostile actions against America prior to 2001. Members of al Qaeda perpetrated the bombing of the World Trade Center in 1993, the East African Embassy bombings in 1998, and the attack on the USS Cole in Yemen in 2000. Although U.S. intelligence agencies knew that another attack was being planned, they did not know when, where, or how it would occur. The 9/11 Commission Report and interrogations of Khalid Sheikh Mohammed (one of the masterminds of September 11) reveal that as early as 1999, al Qaeda leaders began planning to attack targets representing symbols of power in the United States:

- Center of Finance: World Trade Center
- Center of Military: Pentagon
- Center of Government: U.S. Capitol





# It Was An Ordinary Day

The day began with a cloudless, bright blue sky over the mid-Atlantic States. Seven crewmembers assigned to Flight 93 began to prepare for the early morning non-stop flight from Newark, New Jersey to San Francisco, California. Thirty-three passengers were traveling for ordinary reasons, such as business and pleasure. Four other passengers with plans to hijack the aircraft boarded the plane with first-class tickets, never intending to reach San Francisco.



Flight 93 was a Boeing 757-200, with a capacity of 182 passengers. On September 11, the plane had just 37 passengers – only 20% of its capacity. Photo courtesy of Morrie Wiener.

According to the 9/11 Commission, the terrorists strategically targeted domestic flights that:

- normally had few passengers so they would have less resistance;
- used the type of Boeing aircraft that they had been trained to pilot;
- were non-stop, coast-to-coast flights with full fuel tanks that would cause the maximum amount of destruction; and
- were departing at approximately the same time so they could make a coordinated, surprise attack on America.





# “Mayday! Get out of here!”

Captain or First Officer, Flight 93

Despite careful planning by the terrorists, several factors were beyond their control. On the morning of September 11, 2001, three of the four hijacked flights departed on schedule from Boston and Washington, D.C. However, at Newark International Airport in New Jersey, the departure of Flight 93 was delayed more than 25 minutes due to typically heavy morning traffic. Just four minutes after Flight 93 departed, hijacked American Airlines Flight 11 struck the North Tower of the World Trade Center in New York City. At 9:03 a.m., a second hijacked plane, United Airlines Flight 175, hit the South Tower.

At about 9:28 a.m., after 46 minutes of routine flight across New Jersey and Pennsylvania, the terrorists on board Flight 93 overtook the cockpit. Their struggle with the pilot and First Officer was heard and recorded by air traffic controllers in Cleveland, Ohio, and by other pilots tuned to that radio frequency. Either the Captain or the First Officer was heard shouting, “Mayday! Get out of here! Get out of here!” The hijackers gained control of the aircraft and turned it southeast on a course directed toward Washington, D.C., the nation’s capital. At 9:42 a.m., the Federal Aviation Administration ordered all aircraft to land at the nearest airport. An estimated 4,500 aircraft landed safely without incident. This was the first time such an order had been given in United States aviation history.





# We're going to do something.

During the cockpit takeover, the terrorists murdered a flight attendant and one passenger seated in first class, and incapacitated the pilot and co-pilot. The remaining passengers and crew were forced to the back of the plane and told to sit down and be quiet. One of the terrorists claimed to have a bomb strapped around his waist.

Using the airfones from the seat backs in the rear of the plane, passengers and crew began calling their families, friends, and authorities to report the hijacking. They soon learned the shocking news that other hijacked planes had struck the World Trade Center and quickly realized that Flight 93 was part of a larger attack on America. This realization led to a vote and a collective decision to fight back.

The hijackers on September 11, 2001, were terrorists on a suicide mission. This was the first time hijackers used commercial airliners as weapons to destroy symbolic targets, commit mass murder, and spread fear.

# “In the cockpit! If we don’t, we’ll die!”

Shouted by a native English-speaking male

Cockpit Voice Recorder, Flight 93

In little more than 30 minutes, this diverse group of people on Flight 93 realized this was unlike any previous hijacking. They developed a plan and put it into action, waiting until they were over a rural area to take back the plane. The cockpit voice recorder captured the sounds of their struggle: shouts, screams, calls to action, and sounds of breaking glassware.

To stop the uprising, the terrorist piloting the aircraft began to roll it to the left and right, and pitch the nose up and down. Other pilots of aircraft in the area and witnesses on the ground saw the erratic motion of the aircraft as it streaked across the sky.

Over the sounds of the passengers and crew attempting to regain control of the cockpit, a terrorist shouted, “Pull it down! Pull it down!”

In its final moments, the plane turned upside down as it passed over this area, just about 50

feet above the ground. According to the 9/11 Commission, the terrorists remained in control of the plane and chose to crash it here rather than risk the passengers and crew regaining control of the aircraft.

At 10:03 a.m., Flight 93 plowed into the empty field southeast of this building at a speed of 580 miles per hour. Upon impact, the 7,000 gallons of jet fuel on board the aircraft exploded, creating a ball of fire that rose higher than the trees. Many reported that, in the bright sunlight, the black cloud glittered with bits of metal debris.

# “It was just real quiet.”

Within minutes after the crash, first responders from nine volunteer fire departments and emergency response centers arrived on the scene, along with the Pennsylvania State Police.

While some early responders assumed the plane crash was a tragic accident, the State police knew the crash was the result of a hijacking because just minutes before Flight 93 crashed, a passenger called Westmoreland County 911 and reported the hijacking of his United Airlines flight. When state troopers found fragments of a United Airlines in-flight magazine on the ground, they knew they were looking at remains of the hijacked plane.



When first responders and local citizens arrived, the crash site and adjacent trees were still smoldering, and the ground was littered with fragments of the plane. The crater was 15 feet deep and roughly 30 feet across. Photo courtesy of Mark Stahl.

# Intended Target

Washington, D.C.

Because of the quick and determined actions of the passengers and crew, Flight 93 was the only one of the four hijacked aircraft that failed to reach the terrorists' intended target that day. The passengers and crew showed unity, courage, and defiance in the face of adversity.

The flight data recorder that was recovered from the crash site revealed that the terrorists had reprogrammed the aircraft's autopilot system for a new destination – Washington, D.C. Recovered evidence and responses to interrogations revealed that the terrorists' intended target was the United States Capitol, where the nation's legislators were in session. Flight 93 crashed only 20 minutes flying-time from Washington, D.C.

In al Qaeda's early planning, both the White House and the U.S. Capitol building had been identified as possible targets. Although Bin Ladin favored targeting the White House, after evaluating the difficulty of hitting that building, al Qaeda chose to target the U.S. Capitol.
