If you are not satisfied with this action, you may appeal this decision to the Chief, Freedom of Information/Privacy Acts Office, U.S. Small Business Administration, 409 Third St., SW, Washington, DC 20416.

You must submit an appeal within 90 calendar days of the date of the notice of denial. Your appeal should contain a copy of this correspondence, a description of the information requested in addition to what was denied, the name and title of the SBA official or employee who denied the request, the reason for the denial, and any other facts you deem appropriate.
