Dear Mr. Scolinos:

As we noted in our letter dated January 21, 2025, we are processing your request for material under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. The Department of State ("Department") has identified an additional 32 responsive records subject to the FOIA. Upon review, we have determined that 23 records may be released in part, 1 record must be withheld in its entirety, and 8 records originated with another U.S. Government agency. We have referred the latter eight records to the relevant agencies with a request to respond to you directly upon making a release determination.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made redactions, the applicable FOIA exemptions are marked on each record. The record withheld in full is exempt from release pursuant to FOIA Exemptions 3 and 6, 5 U.S.C. §§ 552(b)(3), pursuant 222(f) of the Immigration and Nationality Act, 8 U.S.C. § 1202(f), and (b)(6). The document identification number for the record withheld in full is A-00000842863. Where applicable, the Department has considered the foreseeable harm standard when reviewing these records and applying FOIA exemptions. All non-exempt material that is reasonably segregable from the exempt material has been released and is enclosed.

We will keep you informed as your case progresses. If you have any questions, your attorney may contact Assistant U.S. Attorney Douglas Drier at Douglas.Drier@usdoj.gov or (202) 252-2551. Please refer to the case number, FL-2025-00003, and the civil action number, 24-cv-02883, in all correspondence about this case.

Dear Bridget Brink and Garrick Harmon,

It is my understanding from feedback that I made the Pentagon mad and caused them to abort the Afghan soldier project because of the sentence in one of my notes to Ukraine that said-" My congress contacts say that the Pentagon will donate all the gear if they can get a simple request for the gear." --- I am extremely disappointed that a casual selling point just meant for Ukraine leadership which had propelled us to the point we were at, derailed the whole project. The Council of Governors had approved the project and we had 230 soldiers approved and ready with 1000 to go after that and then 2500 more and it fell apart over some gear and a little funding. We could have added 10,000 to 50,000 Afghan soldiers to the front line and been able to make a significant impact on the course of this war but now I have hundreds now begging for my help with SIV cases so they can go to the US instead. We could have relieved this strain while providing an outlet for all of our friends and partners that we had worked with for 2 decades and put the US in a favorable light with all of the Afghan people by at least giving the soldiers a way to make money and work again instead of being stranded and stateless with little hope of work nor any future in life. I spent several weeks in Taiwan with no success(AIT says they have it handled), reached out to Haiti, Saudi Arabia and others with no response so the only option that these men is my main leader have is to go and fight for Russia. and he is forced to go to Russia now and fight to support his family. He is scheduled to leave in the coming days and if he can finds the arrangement acceptable he will certainly take others as well.

At age 56. I have gone through my entire life always doing everyday what is right and trying to help in any fashion with no regard for money and profit and I sit here penniless and extremely frustrated that on every front and project people fail to respond, help and act towards making our world a better place. This project likewise has fallen on deaf ears and into the lap of everyone once again of successful people that seen to thrive on inaction and deterring progress, yet succeed. I went to every single Congressional office and begged for support as well as the State department and the Pentagon and the White House and the Staff of Biden was the only one to even respond with an email; everyone else ignores this opportunity. The entire world has turned it back on Ukraine and not one single country has sent its army to defend freedom and human rights and we offer a complete NATO trained army to help win the war and it is refused because we cannot find a way to send the soldiers away when we are done with them. How silly and shortsighted are we, that we cannot come up with a long-term solution for the resettlement of these soldiers somewhere in the world. It would seem with the vast land available in the world that we could purchase a small country and find them a home, or negotiate a deal with some country to accept them; as Iran seems to enjoy having such a large cheap labor pool that they are accepting them willingly and putting them to work daily. In this vast world there must be a place that need good hard working people to help build their community and would be willing to accept brave soldiers that were willing to fight and die for freedom and democracy. Why can we not find that place. Let us buy Transnistria or use the entire city block in Chisinau Moldova that we own, or some worldly asset or location; Samoa, or sequester them in Alaska, anything, anywhere to help resolve this war and this refugee crisis. I obviously would like to send them all to Taiwan when we are done with them in Ukraine as a refugee program to prepare for that



war, but everyone is frozen in Taiwan and simply ready to surrender in a day. If we must banish the Afghans to a small outlying Taiwanese island after the Chinese invasion that would be acceptable to these men, they simply do not want to be slaughtered by the Taliban. It seems that any country that is facing conflict such as Haiti would welcome the idea of an influx of trained soldiers to join their workforce towards peace and stability. Why can you and I not be the ones that take on the responsibility for these soldiers and be the ones that manage these soldiers and become responsible for their actions and future. I will gladly establish a private military company or partner with an existing private security company to hire these soldiers and take on the responsibility of managing them and their future, action, and behavior so that Ukraine does not have to hold the bag. If I must be the one that bear all the legal responsibility and be the fall guy for any problems that is the role that I am prepared to accept. The Wagner group worked well for Russia and as a third party it can insulate you and any help you provide as well as insulating Ukraine. This would offer a layer of protection for everyone, and the fear that Ukraine has about soldiers using the media to stir up trouble and push for asylum could be resolved as they would not be working directly for Ukraine, so they can deny any connection to the soldiers, as they are merely private contractors. I have a retired US Army captain (b)(6) that has served in Ukraine from the beginning and is now forming a new private security company already and would like to use the Afghan soldiers so I already have a partner that is working towards this goal, but we will need some support to make this work at all.

The only other crazy option is that if Ukraine does not want these soldiers in Ukraine then let's drop them in Russia at Putin's Black Sea castle and we can destroy it and do whatever it takes get into his bunker and pull him out. One of the Governors on the Ukraine security

council had planned to use 30 of the Afghans as spies in Russia, so they like the deniability of disconnected Afghans that they can say operated independently. We would need a very old plane and parachutes, but I feel that we must take this war to Putin's door at all cost. Putin is the driving force behind this war, and it seems logical that we need to see what happens when he is no longer leading the charge or at minimum when is precious castle is gone. I and the soldiers can hike back to Georgia if we must so that we are detached actors. If we are able to deliver Putin a ride out would be appreciated. These Afghan soldiers are willing to do anything to get out of the situation that they are in now. Kyrylo might even support this plan and give us what we need.

As you know all of the lower-level leadership in every organization are begging for these soldiers to help with the fight, but just Kyrylo (b)(6) and one or two others are fighting this Budanov and project. When we meet with any General or Lieutenant or any branch of the military, they are begging for these soldiers but we cannot get upper leadership to cooperate. As you know Kyrylo Budanov rules with an Iron fist and will kill anyone that goes against his plan and agenda so none of the lower leadership is willing to push this project for fear of (b)(6) with the International legion elimination. As you may know fled when he was threatened by Budanov. They have blocked every ounce of cooperation towards making this project work, such as the official request for the gear to the Pentagon. They said they would work on it but they never intended to send a request. I think that this project is such a logical and natural fit that it seems crazy that we cannot make this project work. I am willing to travel back to Ukraine and spend as long as it takes to make this project work. Please let me know what I can do to make this happen for these poor Afghans and for Ukraine that must have help to win this war.

I hope that you will reach out to me in some form or fashion, and we can work together to make this project happen. I would so appreciate the opportunity to discuss the options and ideas and see if there is a way forward. I certainly would never abuse any line of communication that is established. Please help these soldiers and see if we can change the outcome of this war.

Thank you for your letter to President Joseph R. Biden regarding your comments and suggestions in fixing three global issues at one time.

The White House referred your letter to the U.S. Citizenship and Immigration Services (USCIS) Contact Center. Your letter has been assigned case (b)(6) USCIS is committed to helping the public resolve any problems they might have encountered when applying for immigration services and benefits.

We understand your concerns and are dedicated to providing you with accurate information and guidance. In your letter, you are requesting assistance to push Ukraine to issue visas to thousands of Afghans and Syrian soldiers that are fleeing their homelands, so that they can help with the war in Ukraine. You are requesting support from the United States and would like for President Biden to contact the Ukrainian Ministry of Defense and persuade them to accept these trained soldiers. USCIS is saddened to see the decapitated bodies of innocent people and would like to express our sincere sympathy.

Please understand that USCIS does not have jurisdiction over the issuance of visas. The U.S. Department of State is the only U.S. authority that can grant or deny visas based on the requirements specified in the Immigration and Nationality Act (INA). Under the INA, a citizen of a foreign country who wants to enter the United States must first obtain either a nonimmigrant visa for a temporary stay or an immigrant visa for permanent residence. Please go to the Department of State's website at state.gov to determine what visas these people may need to apply for.

Neither the President of the United States nor any USCIS official has the authority to modify the law to benefit a particular individual.

USCIS policy prohibits us from providing legal advice to private individuals on immigration matters. If you need legal advice, please visit our Find Legal Services web page to get more information.

Honorable Bridget Brink,

My name is from Afghanistan and I served with the Coalition forces for over a decade towards making my homeland safe and a wonderful place for my three children and wife to grow up, but that has fallen apart. I like most Afghans that served with the coalition forces are in hiding or on the run from the ruthless slaughter of the Taliban and I am now forced to live in Iran and work for 3 dollars a day to support my family and keep them fed. It is a life with no hope, future or purpose for any of us, just merely survival. I would much rather be on the battlefield in Ukraine with my life on the line facing bodily injury and death to simply be fighting for democracy and freedom and a better life for someone, anyone on this planet. At least I would know that I died making this world a better place for my little children and show them that doing the right thing is honorable and good even if it ends your life; it is what good humans should do.

I have worked tirelessly now for 2 years talking to every contact in the world that could help me get to Ukraine to fight, and we have gotten close to success, but have not yet been able to get one single Afghan to Ukraine yet and I am extremely frustrated. I have partnered with Ryan Routh whom has helped all of the Afghan soldiers tremendously and took time to travel back to Ukraine for 3 months to beg on our behalf to accept us as soldiers for Ukraine, but as you know we have so far been unsuccessful. We have recently been able to get one invitation letter from the recruiting office in Ternopil for my best friend that speaks English well and he

is trying diligently to get the Ukraine Visa out of the Pakistan office in the coming weeks, but we will still be faced with getting him a transit visa from Moldova or Poland which may prove difficult. It saddens me greatly that we have thousands of Nato trained soldiers that are begging to fight for freedom and democracy and basic human rights and we are not given the opportunity to do so. While the vast majority of the world does not want to get its hands dirty and go about life as normal as this atrocity continues, we have the resource that is needed to end this war. We have enough soldiers to double the size of the Ukraine army and push Russia back where they belong and not let this war drag on for another decade or two or three. We cannot accept this stalemate and the status quo, we must as a global community not allow this to continue and we must be the force that pushes Russia back and makes them pay for the problems they have caused. We must take this battle to the doorstep of Vladimir Putin and blow the doors on his bunker and drag him out for the world to see. The entire world is watching, China and Iran and all of the Rogue nations, and we must ensure that this war is ended swiftly and decisively for the future of human rights and freedom, but we cannot do this without your help. Ukraine is on overload and they do not have the manpower and diligence to implement this project, so we are asking for your help. Zelenskyy is fully aware of this resource and opportunity but does not have the time and patience to implement all of the required details, and why should he carry the weight of the world alone. All we are asking for is to help us get this project started and once we have a core group established we can manage this project as much as Ukraine will allow and make it as easy on everyone as possible. We simple need help establishing that initial path and contacts so that we have a route for these soldiers to travel. There are two ferry boats that cross the Black Sea from Georgia to Romania that we can use to transport soldiers if we cannot fly from Tehran to Moldova or Poland. All of the thousands of soldiers are willing to do whatever is needed to join the fight in Ukraine. We are all willing to walk in a massive caravan from Afghanistan to Ukraine if you can make us a path we will make it happen. It would be a powerful visual for the world to see; thousands of soldiers walking in a group all the way to Ukraine to fight; that is what the world need to see and the powerful image that Ukraine and humanity deserves. If you

could simply provide us with an escort that will allow us all to walk across borders we will make you proud and account for every single soldier from beginning to end. If you can arrange a collection point in Turkmenistan and we will arrange a boat across to Azerbaijan so that we can walk the rest of the way to Ukraine that would be excellent. We cannot sit around and do nothing, we must motivate the world to get involved once again and stand up for what is right. We cannot let this situation linger and continue without bold visible support. We should be the motivators that starts a new round of global support for Ukraine. With the new funding from the US signed today by Biden, I hope that we will have the weapons needed to arm all of the Afghan soldiers to put them directly into battle and have the food and support that this project needs. Ukraine has always suggested that funding was a problem for this project, but maybe with this new round of funds it can start now. We have explained countless times that we fight for less than the normal salary, as this is not about the money, it is standing up for our brothers in Ukraine that wish to remain free and democratic and it is our civic duty to support those that wish to live free. Any salary greater than what we receive in Iran is acceptable; we received between 200 and 300 US dollars when we fought for coalition forces and that was perfect. We simply long for renewed purpose and hope to have a future of usefulness and part of something worthwhile and not in a place without any opportunity, if you can help us.

I am sure that you are aware that soldiers and their families are still being killed daily in Afghanistan with babies' heads being chopped off and soldiers with arms and legs cut off and the most cruel behavior know to man; Afghanistan is no longer a civilized society and we all wish for a normal life free from senseless murder. Please help us find a pathway to Ukraine so that we can be useful again. That is all that we are asking for. If we need to arrange a way to return the soldiers back to Iran or Afghanistan after the war we will gladly set aside funds for return visas and travel expense back home once we are no longer needed. We will gladly agree to having our bodies buried in a grave in Ukraine if we die as well if that makes this project easier. We will agree to whatever terms are demanded to make this project work. We will adhere to whatever is required to guarantee

that arrive in Ukraine and are not lost on the way, if it means shackles and chains we will do whatever is needed to satisfy the authorities and make this work. We will show our loyalty and dedication every step of the way, we will show the world who we are. Please give us the opportunity. That is all we are asking.

Thank you for taking the time to consider our request. I speak for thousands of Afghans that I work with on a daily basis. We are all begging you for your help. I hope that you will email or text me on Whatsapp so we can find a way to move this forward.

I, Ryan Routh would like to respectfully ask why we cannot work one on one to pursue the Afghan soldier project?

I fully understand that your office does not need any unnecessary noise and correspondence that is not worthwhile; but I do not see how we can get these thousands of Afghan soldiers to the front lines without direct communication. Your staff has spoken with (b)(6) at great length and most recently had a meeting where he was asked to provide the execution details of the project as well as accounting of how funds would be allocated and spent and he failed to submit those documents to you. While I had hoped that he could produce these documents, if he could not, I had hoped that you would reach out to me so that I can supply what you need. I will gladly do whatever it takes to get you the information that you need from any number of Ukrainian agencies so that we can get this project done. I can be back in Ukraine at a moment's notice and arrange (b)(6) did not fulfill his obligation he is ashamed to what you need. Because give me any contact information since he dropped the ball. We have been (b)(6)for months discussing this and mailing documents and talking through so it seems only logical that we at least have an email address that we can work through to try and make this happen. When I went to Taiwan the personnel at AIT came right out and we had a meeting right then and there and discussed all the items and options without hesitation and any issues. If you can possibly assign a low level spokesperson that can help with some simple emails that would be wonderful.

Currently (b)(6) is negotiating with GUR and they have requested that we assemble a complete battalion of 3000 Afghan soldiers that have passports so we are working on that currently. I am sending the leaders of the Afghans to Qatar to set up an office so that we can compile this list in safety away from the Taliban

and Iran. As you may know, with Reznikov and Budanov we had an agreement to bring in 230 Afghan soldiers on a trial basis to join the International Legion, with plans for another 1000 and 2500 after that, but that fell apart with leadership changes and the constant begging for money. I have since mailed a package to (b)(6) has met with Zelenskyy but no defined movement Rustem Umerov and yet. With your simple partnership and encouragement I am certain that we together can iron out all of the minor issues and make this project a tremendous benefit for everyone. Again, we can use a private security company and my friend that was a captain in the U5 Army to help coordinate this project if or if you would like to work with needed. He can be reached at my Washington DC partner (b)(6) or you can work with my as she is near your office and office person can meet you anytime to discuss what is needed. However you wish to communicate or whomever you are most comfortable speaking with as long as we can have more open lines of communication so that we can move this project forward. As the world is becoming more engulfed in conflict and now the with such chaos Taiwan is ripe for the picking, we must put all hands on deck to push harder for Ukraine to be finished so we can move resources to Taiwan as quick as possible. These conflicts grow more critical everyday and we cannot let these valuable assets sit idle as a global conflict between democracy and dictators happens before our eyes. We cannot let our lack of good communication fail us at this critical moment. Please open these lines of communication so that we can help fix these major problems. Please help me.

Dear Honorable Ambassador Bridget Brink,

(b)(6)says that he met with you directly about the Afghan soldier project and he says that you had requested a plan for accounting for any funding that you might offer to help the Afghan soldiers get to the front lines. He had stated once that he did not provide the documents, but recently claims that he did provide the requested documents and never got a response. Either way he claims that he has lost all contact information for the Embassy and that the project is dead. I would very much like to restart the discussion and as (D)(O) is extremely busy it may be easier if you were able to designate someone that would be willing to work with me directly on this project by email if possible. I would be so grateful if we could establish any sort of line of communication, beyond the postal system. I am willing to do whatever is needed to help make this project work. I can fly back to Ukraine and arrange whatever accounting or paperwork that you need; we have countless units and commanders that will work with us to provide anything that is required and I will work on it as long as it takes. I currently have about 1000 Afghan soldiers with passports and tens of thousands that do not have passports. We also have plenty of Syrian and Yemen soldiers that wish to fight.

I have enclosed my most recent letter to Biden, as well as the response to my letter from many months ago. I will not reiterate what it says, but the message is that with Congress slowing down cash funding for Ukraine we must find new ways to directly help ensure we win this war and if we can find these Afghans some old gear and arrange some

transport and some food and just a little money for pay they would be grateful. They make 3 to 4 dollars a day where they are and we paid these soldiers 200 dollars a month to fight in Afghanistan. If we can hire them outside of the Ukraine army we can pay them much less and be the financial savings that Ukraine is looking for. Ukraine does not want the burden of these Afghan soldiers if they do not have an incentive to take them; so they keep asking for money to go along with the package as you know. I think I have covered almost every angle of this project in the countless letters. As I have mentioned before, I and the Afghans are willing to march straight to Putin's castle on the Black see just like the caravan of migrants from South America headed to the US if you can get us passage through Armenia or Azerbaijan and through Georgia and have us a few weapons at the Russian boarder so we can fight our way to the castle and some funds for those that die or survive when we return. The Afghan soldiers are willing to even do this mission with no gear, and as I have stated before several have stated they will fight naked if we must. We must make a powerful stand with a powerful message. What would be more motivating than thousands of foreigners marching into Russia to fight the Russians. ЗВЕРНЕННЯ КОЛЕКТИВУ РЕДАКЦІЇ

Ми звертаємось до Вас, як до представника США, які всіляко допомагають Україні, дякуємо. За гроші США, шляхом перерозподілу коштів у бюджеті України фінансується діяльність державного апарату України, включаючи Національної поліції, Офіс президента та Офіс генерального прокурора. Ми звертаємось до Вас, бо вже вичерпані усі можливості для захисту журналістів редакції інформаційного агентства "Актуальна Правда" від переслідування з боку влади України. Народ Сполучених Штатів Америки, який Ви представляєте, для нас остання надія, для захисту наших прав і свобод.

Одночасно з початком тиску на редакцію "Бігус Інфо", почалася атака на редакцію "Актуальна Правда". 25 січня 2024 року, до матері Сергія і Костянтина Медяників - співзасновників "Актуальної Правди", яка мешкає у містечку Нова Водолага, Харківської області, завітав чоловік (не представився), та повідомив, що ії син Сергій Медяник знаходиться у розшуку поліції. Звісно у жінки, якій зараз 74 роки, піднявся тиск і вона добу не мала змогу встати з ліжка через хвилювання. Тобто, що людину, спеціально було відправлено, як кур'єра для здійснення психологічного тиску.

1 лютого 2024 року, дві людини у цивільному, приїхали до міста Харків, до будинку, де раніше мешкали бабуся та дідусь Сергія і Костянтина Медяників - співзасновників "Актуальної Правди". Будиночок на 60 квадратних метрів, побудований після Другої світової війни, зараз оформлений на Костянтина Медяника. Ці чоловіки почали гатити по воротах сусідніх будинків, коли до них виходили власники, вони показували фото журналіста Сергія і Костянтина

Медяників та казали, що вони зараз у розшуку поліції у зв'язку (далі цитата): "Вони перейшли дорогу серйозним людям". В цей же день, ці чоловіки, через дільничного поліції Немишлянський відділу поліції Харкова області знайшли двоюрідного племінника, який працює у цьому ж відділку поліції. Саме він повідомив Сергія і Костянтина Медяників, про те що їх шукають чоловіки, які йому показали посвідчення поліцейських. Під час спілкування з ним, вони зателефонували на мобільний телефон журналіста Костянтина Медяника з номеру +380957598352, який у Getcontact підписаний: "Начальник управління Вінницької області". Чоловік не представився і сказав, що хоче просто Актуальної журналістн наступний день, поспілкуватися. Ha зателефонували на цей номер з метою отримання коментаря, з якою метою він телефонував до журналіста Костянтина Медяника, у відповідь чоловік на російській мові відповів: "Помилився номером". До нас у редакцію передали фото чоловіка, який приїздив до будинку Костянтина Медяників, ми зробили відповідний запит до поліції та прокуратури, але у порушення законодавства, відповідь так і не надійшла. З 2012 року, Сергій і Костянтин Медяники співзасновники "Актуальної Правди", мешкають у Києві де активно здійснюють діяльність журналіста. Тому приїзд поліції у Харків, ми розцінюємо, як тиск та дискредитацію з метою пашлюження репутації редакції "Актуальна Правда".

Ми розуміємо, чому приїздили ноліцейські саме з Вінницької області. У серпні 2021 року, журналіст Сергій Медяник, приїхав до міста Вінниця, за запрошенням місцевих мешканців, які приймали участь у Другій світовій війні та АТО (війні з Росією), вони пожалілися, що у місцевому шпиталі для ветеранів війни систематично розкрадаються кошти на лікування. Поспілкувавшись з людьми, виявилось, що Володимир Гройсман (він зараз не займаючі жодиої посади, контролює Вінницьку область), який з 26 березня 2006 до 27 лютого своїм особистим Вінницького міського голови, 2014 посаду розпорядженням, у 2013 році, роздербанив частину земель, які були надані для шпиталю. На цій вкраденій землі були побудовані елітні будинки, у тому числі родичів Гройсмана, місцевої політичної еліти та головного лікаря шпиталю ветеранів. Проаналізувавши політичну картину Вінницької області, ми зробили висновок, що на сьогоднішній день, особиста партія Гройсмана: "Українська Стратегія Гройсмана", контролює всі важелі впливу у регіоні. Нагадаємо. що Гройсман був фігурантом кримінальної справи НАБУ щодо отримання хабаря від Укрбуду, по цій же справі проходив Татаров, який відповідає у офісі Зеленського за координацію силових органів України, також Татаров є адвокатом олігарха Ахметова, якому приписують спонсорування партії Гройсмана. Обидва, якимось чудом, уникли покарання. Потрібно зазначити, що журналіст Сергій Медяник отримав у 2021 року від джерел з СБУ, що Зеленському у Глазго, спецслужби Великобританії надали інформацію, яка мала бути підставою для ув'язнення олігарха Ахметова. Журналіст Сергія Медяник робив на цю тему репортаж і виступав на мітингу біля офісу Ахметова, який знаходиться навпроти Міністерства іноземних справ України.

Гройсман контролює призначення усіх державних посад Вінницької області. Шпиталь ветеранів підпорядковується Вінницькій обласній раді, яку очолює Соколивий, він представляє партію "Українська Стратегія Гройсмана" та багато років був керівником Вінтилької обласної прокуратури. В день приїзду журналіста Сергія Медяника, було проведено мітинг біля шпиталю, де він виступав. Далі ветерани почали проводити мітинг біля будинку в якому знаходиться голова Сергій Борзов - голова Вінницької обласної адміністрації та Вінницька обласна рада. Нагадаємо, що Сергій Борзов має дружину, народну депутатку Ірину Борзова, у якої батько Баруля, приймав на роботу у Москві молодого Зеленського. А зараз Баруля є співвласником "Ліги Сміху" особистого бізнес проекту Зеленського. Спочатку мітинг оточили поліцейські роти особливого призначення "ТОР" у кількості 50 чоловік, нотім приїхало 20 бійців батальону особливого призначення поліції Вінницької області, вони були озброєні автоматами. Бійці спецзагону, схопили журналіста Сергія Медяника та вивезли за 30 кілометрів у Калинівський відділ поліції, при цьому не зачитали права. Там вони протримали Сергія Медяника 3 години у громадській приймальні разом з дізнавачем, в цей час спецзагін у кількості 30 бійців з автоматами оточили будівлю поліції. Коли спливло 3 години адміністративного арешту, журналіст Сергій Медяник, запитав у бійця спецзагону, чи він вільний, той відповів, що підстав його тримати вже нема. Журналіст Сергій Медяник сів у редакційне авто, яке спочатку заблокувало таксі, а по боках вишикувалися співробітники поліції цього Калинівського відділу у кількості 50 чоловік. Потім таксі відігнали і редакційне авто було заблоковано поліцейськими авто. Це усе дійство тривало 5 годин. Поки журналіст Сергій Медяник сидів у авто, поліцейські погрожували, що будуть вибивати скло. Потім поліцейські щось розповідалн на камеру та приклеїли до скла авто два папірці, які виявились підозрами за двома кримінальними справами щодо журналіста Сергія Медяника. Далі з Вінниці приїхали слідчі ДБР, яких викликав журналіст Сергій Медяник і всі поліцейські повтікали. Журпаліст Сергій Медяник новернувся у Київ, винайняв адвоката, який подав скаргу у суд, з проханням закрити кримінальну справу, бо якщо за 20 днів у кримінальному проступку не проходить слідчих дій, то згідно КПК поліція повинна закрити справу. Слідчий суддя видав рішення, щоб поліція розібралась згідно закону.

Редакція "Актуальна Правда" подала заяву про злочин поліцейських до Офісу генерального прокурору, у відповідь було відкрито кримінальну справу, яка не була розслідувана. Також ми почали розслідування щодо поліції Вінницької області і виявили, що їх керівник Іщенко керував тітушками 2 травня 2014 року, які у центрі Одеси вбивали активістів Євромайдану. У жовтні 2021 року, Іван Іщенко, який тоді був начальником поліції Вінницької області (зараз керує Чернігівською обласною поліцією), ініціював зустріч з журналістом Сергієм Медяником у Києві, де висловив бажання зупинити переслідування журналіста Сергія Медяника. У грудні 2021 року, на стоянці стадіону Олімпійський у Києві, 6 поліцейських Вінницької області разом з двома понятими - працівниками футбольного клубу "Шахтар" (власник олігарх Ахметов), оточили журналіста Сергія Медяника. Він зміг вирватися та почав їх знімати на відео, у відповідь, вони приклеїли до авто журналіста Сергія Медяника папірець. Він виявився ще однією підозрою у третій кримінальній справі, які потім були об'єднані у одну. У 2022 році, поліція та прокуратура 5 разів подавати у суд з метою запроторення у СІЗО журналіста Сергія Медяника. Їм було відмовлено. У 2023 році поліція та прокуратура подала знову клопотання на запобіжний захід, щоб запроторити журналіста Сергія Медяника у в'язницю. Це клопотання слухалось півроку, судля відмовив і написав, що спосіб вручення підозр журналісту Сергію Медянику не відповідає закону. У апеляційному суді, це було підтверджено.

На журналіста Сергія Медяника, сфальсифіковано кримінальну справу, його звинувачують, що він написав заяву про злочин на патрульного поліцейського Сергія Завальнюка, бо вбачав у його діяльності корупцію. 

Dear US Embassy,

I wanted to request a meeting with the Office of Defense Cooperation if possible. We are working on a project with Ukrainian MOD to bring substantial numbers of Afghan soldiers that are now refugees to Ukraine to fight on the front lines. MOD would like for this to be a joint operation with the US embassy to collaborate and advise. We are already supplying background checks from the US military through Representative Barry Moore of Alabama, but Ukraine would feel more comfortable with more interaction, support and encouragement from the US. We have 5600 soldiers ready to be transported from Pakistan to a neighboring country of Ukraine and bussed into Ukraine to the front lines to fight. We are working on arrangements for gear, but the Afghans would like Ukraine to provide some small salary to fight as well as food and weapons.

This is an ideal opportunity to fix several problems at one time which is rare. These men are begging for some hope and purpose and the Ukrainians certainly need the help, while Russians are recruiting these same soldiers, we cannot let the fact that we do not create a path and financial desperation land them on the wrong side of this war.

Just a simple meeting and a few phone calls and we can hopefully change the course of countless lives and influence the outcome of this war. Thanks for your time and I hope that we can make this project happen. I am here in Kyiv as long as it takes to make this project work.



"Trump has once again started 'assassination attempt' clownery. Trump's rating has fallen, and his spin doctors did not come with anything better than 'another attempt on Trump's life'. This time they have done more foolishly and primitively," pundit Oleksandr Okhrymenko said on Facebook.

Former diplomat Oleh Sharp suggested on Telegram that the "assassination attempt" on Trump was linked to his post on Truth Social where he said "I hate Taylor Swift".

"Personally I have doubts about an outsider shooting near Trump's golf club because all the outskirts of his residence in Florida are guarded better than the White House. As for his guards shooting in the air... well, it is part of the script," Sharp said. "I understand that the Trump team wanted to divert attention from his silly post to something spicy, but the granddad should have come up with something better that assassination attempts and shooting long ago. And although someone has been detained, it seems to me that was a comedy."

"Trump has been shot at again. The Americans may get used to it by polling day just like Kyiv residents have got used to missile strikes," pundit Yuriy Romanenko said on X.

Suspect

The Kyiv Post newspaper profiled the suspect.

"After unsuccessfully attempting to join the Ukrainian Army, the suspect in yesterday's attempted assassination of former President Trump, Ryan Routh spent a few months in Kyiv with intent of associating himself with the war effort. Publicly available social media sources from the time of his visit warned that Routh was misrepresenting himself as a 'recruiter' for the Ukrainian Armed Forces. According to the New York Post and CNN, the man actively supported Ukraine on social media. In 2022, he wrote that he was ready to volunteer in Ukraine, and in 2023, he mentioned spending several months in the country after the start of the Russian invasion," the Kyiv Post said on Facebook in English.

Russian propaganda to benefit?

Prominent pundit Vitaliy Portnykov described Routh as an "extremely controversial" figure. He said on YouTube that the Trump election campaign would try to link this "situation" to the suspect's personality, to "him allegedly facilitating an escalation in the Russian-Ukrainian war". Portnykov also warned of the risk of further "political violence".

"All of us understand full well that attempts on politicians' lives, including Donald Trump's, will continue. And even if Donald Trump wins the US presidential election, he will still be in danger throughout his term in office. Trump and assassination attempts are now two realities that encounter each other at the wrong time," Portnykov predicted.

The head of the Centre for Countering Disinformation under the National Security and Defence Council, Andriy Kovalenko, said on Telegram that Russia would try to take advantage of the incident.

"Russia is using another attempt on Trump's life against Ukraine in the media," he said.

"The incident is already becoming a topic for Russian propaganda. The enemy will later launch a number of conspiracy theories about the 'Ukrainian trace'."

Mainstream media

Ukrainian mainstream media have carried factual reports on the apparent assassination attempt on Donald Trump.

"The Trump election HQ said that shots had been fired near the politician," the <u>NV website said</u> in its headline.

"The FBI is investigating the apparent assassination attempt on Trump," the Ukrayinska Pravda news and analysis website said.

"Another assassination attempt? The Trump election HQ said shots had been fired near him," the RBC-Ukraine website said.

Honorable Bridget Brink,

My name is from Afghanistan and I served with the Coalition forces for over a decade towards making my homeland safe and a wonderful place for my three children and wife to grow up, but that has fallen apart. I like most Afghans that served with the coalition forces are in hiding or on the run from the ruthless slaughter of the Taliban and I am now forced to live in Iran and work for 3 dollars a day to support my family and keep them fed. It is a life with no hope, future or purpose for any of us, just merely survival. I would much rather be on the battlefield in Ukraine with my life on the line facing bodily injury and death to simply be fighting for democracy and freedom and a better life for someone, anyone on this planet. At least I would know that I died making this world a better place for my little children and show them that doing the right thing is honorable and good even if it ends your life; it is what good humans should do.

I have worked tirelessly now for 2 years talking to every contact in the world that could help me get to Ukraine to fight, and we have gotten close to success, but have not yet been able to get one single Afghan to Ukraine yet and I am extremely frustrated. I have partnered with Ryan Routh whom has helped all of the Afghan soldiers tremendously and took time to travel back to Ukraine for 3 months to beg on our behalf to accept us as soldiers for Ukraine, but as you know we have so far been unsuccessful. We have recently been able to get one invitation letter from the recruiting office in Ternopil for my best friend that speaks English well and he

is trying diligently to get the Ukraine Visa out of the Pakistan office in the coming weeks, but we will still be faced with getting him a transit visa from Moldova or Poland which may prove difficult. It saddens me greatly that we have thousands of Nato trained soldiers that are begging to fight for freedom and democracy and basic human rights and we are not given the opportunity to do so. While the vast majority of the world does not want to get its hands dirty and go about life as normal as this atrocity continues, we have the resource that is needed to end this war. We have enough soldiers to double the size of the Ukraine army and push Russia back where they belong and not let this war drag on for another decade or two or three. We cannot accept this stalemate and the status quo, we must as a global community not allow this to continue and we must be the force that pushes Russia back and makes them pay for the problems they have caused. We must take this battle to the doorstep of Vladimir Putin and blow the doors on his bunker and drag him out for the world to see. The entire world is watching, China and Iran and all of the Rogue nations, and we must ensure that this war is ended swiftly and decisively for the future of human rights and freedom, but we cannot do this without your help. Ukraine is on overload and they do not have the manpower and diligence to implement this project, so we are asking for your help. Zelenskyy is fully aware of this resource and opportunity but does not have the time and patience to implement all of the required details, and why should he carry the weight of the world alone. All we are asking for is to help us get this project started and once we have a core group established we can manage this project as much as Ukraine will allow and make it as easy on everyone as possible. We simple need help establishing that initial path and contacts so that we have a route for these soldiers to travel. There are two ferry boats that cross the Black Sea from Georgia to Romania that we can use to transport soldiers if we cannot fly from Tehran to Moldova or Poland. All of the thousands of soldiers are willing to do whatever is needed to join the fight in Ukraine. We are all willing to walk in a massive caravan from Afghanistan to Ukraine if you can make us a path we will make it happen. It would be a powerful visual for the world to see; thousands of soldiers walking in a group all the way to Ukraine to fight; that is what the world need to see and the powerful image that Ukraine and humanity deserves. If you

could simply provide us with an escort that will allow us all to walk across borders we will make you proud and account for every single soldier from beginning to end. If you can arrange a collection point in Turkmenistan and we will arrange a boat across to Azerbaijan so that we can walk the rest of the way to Ukraine that would be excellent. We cannot sit around and do nothing, we must motivate the world to get involved once again and stand up for what is right. We cannot let this situation linger and continue without bold visible support. We should be the motivators that starts a new round of global support for Ukraine. With the new funding from the US signed today by Biden, I hope that we will have the weapons needed to arm all of the Afghan soldiers to put them directly into battle and have the food and support that this project needs. Ukraine has always suggested that funding was a problem for this project, but maybe with this new round of funds it can start now. We have explained countless times that we fight for less than the normal salary, as this is not about the money, it is standing up for our brothers in Ukraine that wish to remain free and democratic and it is our civic duty to support those that wish to live free. Any salary greater than what we receive in Iran is acceptable; we received between 200 and 300 US dollars when we fought for coalition forces and that was perfect. We simply long for renewed purpose and hope to have a future of usefulness and part of something worthwhile and not in a place without any opportunity, if you can help us.

I am sure that you are aware that soldiers and their families are still being killed daily in Afghanistan with babies' heads being chopped off and soldiers with arms and legs cut off and the most cruel behavior know to man; Afghanistan is no longer a civilized society and we all wish for a normal life free from senseless murder. Please help us find a pathway to Ukraine so that we can be useful again. That is all that we are asking for. If we need to arrange a way to return the soldiers back to Iran or Afghanistan after the war we will gladly set aside funds for return visas and travel expense back home once we are no longer needed. We will gladly agree to having our bodies buried in a grave in Ukraine if we die as well if that makes this project easier. We will agree to whatever terms are demanded to make this project work. We will adhere to whatever is required to guarantee



Thank you for taking the time to consider our request. I speak for thousands of Afghans that I work with on a daily basis. We are all begging you for your help. I hope that you will email or text me on Whatsapp so we can find a way to move this forward.

Dear Bridget Brink.

I, Ryan Routh would like to respectfully ask why we cannot work one on one to pursue the Afghan soldier project?

I fully understand that your office does not need any unnecessary noise and correspondence that is not worthwhile; but I do not see how we can get these thousands of Afghan soldiers to the front lines without direct communication. (b)(6) at great length and most recently Your staff has spoken with had a meeting where he was asked to provide the execution details of the project as well as accounting of how funds would be allocated and spent and he failed to submit those documents to you. While I had hoped that he could produce these documents, if he could not, I had hoped that you would reach out to me so that I can supply what you need. I will gladly do whatever it takes to get you the information that you need from any number of Ukrainian agencies so that we can get this project done. I can be back in Ukraine at a moment's notice and arrange what you need. Because (D)(6) did not fulfill his obligation he is ashamed to give me any contact information since he dropped the ball. We have been discussing this and mailing documents and talking through (b)(6) for months so it seems only logical that we at least have an email address that we can work through to try and make this happen. When I went to Taiwan the personnel at AIT came right out and we had a meeting right then and there and discussed all the items and options without hesitation and any issues. If you can possibly assign a low level spokesperson that can help with some simple emails that would be wonderful.

Currently (b)(6) is negotiating with GUR and they have requested that we assemble a complete battalion of 3000 Afghan soldiers that have passports so we are working on that currently. I am sending the leaders of the Afghans to Qatar to set up an office so that we can compile this list in safety away from the Taliban

and Iran. As you may know, with Reznikov and Budanov we had an agreement to bring in 230 Afghan soldiers on a trial basis to join the International Legion, with plans for another 1000 and 2500 after that, but that fell apart with leadership changes and the constant begging for money. I have since mailed a package to has met with Zelenskyy but no defined movement Rustem Umerov and yet. With your simple partnership and encouragement I am certain that we together can iron out all of the minor issues and make this project a tremendous benefit for everyone. Again, we can use a private security company and my friend (b)(b) that was a captain in the U5 Army to help coordinate this project if (b)(6) or if you would like to work with needed. He can be reached at my Washington DC partner (b)(6) or you can work with my as she is near your office and office person can meet you anytime to discuss what is needed. However you wish to communicate or whomever you are most comfortable speaking with as long as we can have more open lines of communication so that we can move this project forward. As the world is becoming more engulfed in conflict and now the with such chaos Taiwan is ripe for the picking, we must put all hands on deck to push harder for Ukraine to be finished so we can move resources to Taiwan as quick as possible. These conflicts grow more critical everyday and we cannot let these valuable assets sit idle as a global conflict between democracy and dictators happens before our eyes. We cannot let our lack of good communication fail us at this critical moment. Please open these lines of communication so that we can help fix these major problems. Please help me.
