Freedom of Information Act Request: U.S. Diesel Fuel Shortages

Dear FOIA Officer:

America First Legal Foundation is a national, nonprofit organization working to promote the rule of law in the United States, prevent executive overreach, and ensure due process and equal protection for all Americans, all to promote public knowledge and understanding of the law and individual rights guaranteed under the Constitution and laws of the United States. To that end, we file Freedom of Information Act (FOIA) requests on issues of pressing public concern, then disseminate the information we obtain, making documents broadly available to the public, scholars, and the media. Using our editorial skills to turn raw materials into distinct work, we distribute that work to a national audience through traditional and social media platforms. AFL's email list contains over 33,900 unique addresses, our Facebook page has 80,000 followers, our Twitter page has over 23,000 followers, the Twitter page of our Founder and President has over 280,000 followers, and we have another 31,400 followers on GETTR.

I. Background

On October 28, 2022, Mansfield Energy—a major fuel and supply logistics company—warned of an impending diesel shortage in the southeastern United States. “Poor pipeline shipping economics and historically low diesel inventories are combining to cause shortages in various markets throughout the Southeast.”¹ Reportedly, the States likely to suffer the most are Alabama, Georgia, Tennessee, North Carolina, Maryland, Virginia, and South Carolina.²

Also, on October 25, 2022, the Energy Information Administration reported that the United States only had 25 days of fuel supply remaining.³ Even as domestic fuel inventories are at historic seasonal lows with pockets along the East Coast running out of—or rationing—supplies, the United States is exporting record amounts of both crude and fuel oil.⁴ At the same time, apparently to mitigate the increased cost of gasoline in advance of the 2022 midterm elections, the Strategic Petroleum Reserve has been emptied substantially.⁵

Facially, the diesel fuel shortage is eerily reminiscent of the ongoing baby formula shortage. Here too, the American people have had little to no advance warning of the diesel shortage. And despite similar warning signs, President Biden and his Administration appear to have taken little action to prevent a fuel shortage and are providing scant information about concrete plans to remedy the shortage and effectively address the associated food supply and other national security risks. Accordingly, AFL requests the following records under the Freedom of Information Act (FOIA), 5 U.S.C. § 552(a).

II. Requested Records

- A. All communications, from any of the custodians mentioned in Part III, containing the word “diesel” or “fuel” and any of the following terms: “shortage,” “rationing,” “supply chain” or “prices.” The timeframe for this request is April 1, 2022, through the date of processing.
- B. All communications with an email address ending in “eop.gov” from any of the custodians mentioned in Part III containing the words “diesel” or “fuel.” The timeframe for this request is April 1, 2022, through the date of processing.
- C. All records relating to or regarding the processing of the above items.

V. Expedited Processing

AFL requests expedited processing for the above-requested items under 5 U.S.C. § 552(a)(6)(E) and 49 C.F.R. § 7.31(c).

Our status as a qualified non-commercial public education and news media requester has been recognized by the Department of Defense, Education, Energy, Interior, Health and Human Services, and Homeland Security, and the Office of the Director of National Intelligence. Additionally, as reflected by the widespread and exceptional media interest in and attention to the reported diesel shortage, there is an urgency to inform the public regarding the circumstances surrounding the shortage of diesel fuel, the risks such shortages pose to the U.S. supply chain, particularly the food and

heating fuel supply throughout the country, and the Department's efforts to address the shortage.⁷
