Dear Reed Rubinstein:

While processing your Freedom of Information Act (FOIA) request dated August 31, 2022, for various communications and records from its Voting Section, the Civil Rights Division (CRT) located and referred a set of documents to this Office for processing and direct response to you. For your reference, the CRT request number associated with your request is 21-00291-F.

At this time, I have determined that eleven pages containing records responsive to your request are appropriate for release with certain information withheld pursuant to Exemptions 5 and 6 of the FOIA, 5 U.S.C. § 552(b)(5) and (b)(6), and copies are enclosed. An additional four pages are being withheld in full pursuant to Exemption 5 of the FOIA, 5 U.S.C. § 552(b)(5). Exemption 5 pertains to certain inter- and intra-agency communications protected by the deliberative process privilege. Exemption 6 pertains to information the release of which would constitute a clearly unwarranted invasion of personal privacy. Please be advised that we have considered the foreseeable harm standard when reviewing records and applying FOIA exemptions. Finally, please note that the remaining pages referred to this Office by CRT, as well as a portion of the enclosed pages, contain duplicative records, which have not been processed.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c) (2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
