Dear Mr. Rubinstein:

This letter is in response to your U.S. General Services Administration (GSA) Freedom of Information Act (FOIA) request number GSA-2023-001268 which was perfected on April 28, 2023. You have requested:

A. All records of, mentioning, or regarding the "Public Statement on the Hunter Biden Emails" dated October 19, 2020, <https://politi.co/3LhhJzs>, and attached as Exhibit A.

B. All emails, SMS text, Signal, WhatsApp, or other written or recorded communications, including recordings from Microsoft Teams Meetings or on encrypted messaging networks, to include external communications, or similar messaging platforms with the following terms:

- "Hunter J. Biden" and "laptop"
- "disinformation"
- "Russian hacking organization"
- "APT28"
- "Aspen Digital Hack-and-Dump Working Group"
- "The Burisma Leak"
- "Russian propaganda dump"

C. All emails mentioning "Hunter J. Biden" and "laptop" in addition to the custodians listed above, with any of the following accounts:

- @westexec.com
- @pbc.upenn.edu
- @nationalsecurityaction.org
- robinware456@gmail.com

D. All records regarding the processing of these items."

Please be advised that after searching our records, GSA does not have records responsive to your request.
